## **AN ORDINANCE**

## TO CREATE A SPECIAL TAX DISTRICT IN THE LATOSCA SUBDIVISION; TO DEFINE THE BOUNDARIES OF THE DISTRICT AND THE PURPOSE FOR WHICH IT IS CREATED; TO ESTABLISH THE LATOSCA SPECIAL TAX DISTRICT AS AN ADMINISTRATIVE DIVISION OF GREENVILLE COUNTY; AND TO IMPOSE A TAX LEVY OF NOT MORE THAN NINETY NINE DOLLARS (\$99.00) ANNUALLY ON ALL REAL PROPERTY LOCATED WITHIN THE DISTRICT.

## **BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:**

<u>Section 1.</u> <u>Findings.</u> Pursuant to Section 4-9-30(5)(a)(ii) of the Code of Laws of South Carolina 1976, as amended, seventy-five percent (75%) of the resident freeholders owning seventy-five percent (75%) of the assessed valuation of the real property in the proposed Latosca Special Tax District submited a petition to Greenville County Council requesting that an ordinance be enacted to establish a special tax district for certain purposes hereinafter set forth, and that a maximum uniform service charge not to exceed Ninety-Nine Dollars (\$99.00) be placed on all real property located within the boundaries of the District. The petition has been verified as meeting the requirements for the formation of a special tax district.

Special Tax District, the boundaries of which include the following properties:

Section 3. <u>Purpose</u>. The purpose and function of the Latosca Special Tax District herein established shall be as follows:

To provide for the health, safety, and welfare of its citizens by funding the costs of street lighting within the District.

Section 4. <u>Administrative Division of Greenville County.</u> The Latosca Special Tax District shall be operated as an administrative division of Greenville County.

Section 5. <u>Uniform Service Charge.</u> The Auditor and Tax Collector of Greenville County are hereby directed to assess and collect a uniform service charge of not more than ninety-nine dollars (\$99.00) annually on all real property within the Latosca Special Tax District. All monies collected from this uniform service charge shall be credited to the District.

<u>Section 6.</u> <u>Contract Rates.</u> The provision of lighting is being acquired by agreement with the electric utility provider in the area. Should utility rates increase, the County may re-establish a new maximum service charge in order to maintain lighting within the District.

**<u>Section 7.</u> <u>Effective Date.</u>** This ordinance shall take effect upon its adoption.
