#### TRAINING

Greenville County is requesting \$5,750 for the purchase of supplies to be utilized by CERT participants and instructors and to purchase CERT backpacks filled with emergency supplies. Greenville County CERT has trained over 400 CERT participants since its inception and funding support is needed to ensure the program can continue to meet the needs of our citizens by educating them about disaster preparedness for hazards that may impact our area and training them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. We need CERT participant and instructor manuals, fire extinguishers for them to practice putting out fires, and CERT backpacks filled with emergency supplies to give to each person who successfully completes the course, passes the written exam and participates in the final exercise.

\$1,000 for CERT participant and instructor manuals

\$3,250 for CERT backpacks filled with emergency supplies

\$1,500 for fire extinguishers to be used in fire suppression exercises for CERT participants

#### PLANNING

Greenville County is in the process of procuring an emergency notification system for our residents. This system will allow us to notify targeted audiences whenever there is a public safety concern or emergency, providing them with timely information that could safe their lives. However, our system is only as effective as our database, and we cannot purchase cell phone data. With people increasingly choosing cell phones over traditional landlines, the importance of a public awareness campaign is crucial. We need to get the message out that residents of Greenville County can register their cell phones on our website to receive important emergency notifications.

The Greenville County Citizen Corps Council would like to spearhead a campaign to raise awareness and educate the public about the opportunity to register cell phones and email addresses, as well as opt in to receive tornado and flood warnings. They are requesting \$3,000 to purchase magnets, brochures/flyers, signs, postcards, postage, etc. to conduct a public awareness campaign.

\$3,000 for promotional materials such as magnets, brochures/flyers, signs, postcards, postage, etc.

#### PRIORITY NOTE:

The top priority for Greenville County is maintaining our CERT program. Funds would go to this objective first. If additional funds are available, we would like to use them for the public awareness campaign for our new emergency notification system. If more money is available beyond what we have requested, we would use it to purchase additional CERT backpacks.
