A RESOLUTION

TO ENLARGE THE BOUNDARIES OF THE GREATER GREENVILLE SANITATION DISTRICT TO INCLUDE CERTAIN PROPERTIES IN THE RIVER MIST SUBDIVISION, AND CERTAIN PROPERTIES LOCATED OFF OF OAKVALE ROAD, ARTURO ROAD, PASCO COURT, EVELYN DRIVE, AND BURBANK DRIVE; AND TO PROVIDE FOR PUBLIC NOTICE THEREOF.

WHEREAS, pursuant to Section 6-11-410, <u>et seq.</u>, of the Code of Laws of South Carolina, 1976, as amended ("S.C. Code Ann."), the governing bodies of the several counties of the State are authorized to enlarge, diminish or consolidate any existing special purpose districts located within such counties; and the Greenville County Council is the governing body of Greenville County, South Carolina; and

WHEREAS, the Greater Greenville Sanitation District ("District") was created pursuant to Act No. 1543 of the 1968 Acts and Joint Resolutions of the General Assembly of the State of South Carolina, and as such is a special purpose district created prior to March 7, 1973 to which has been committed the function of collecting refuse, garbage and trash within the district, and to engage in the operations of dumps or landfills for the orderly disposal of refuse, garbage and trash within Greenville County; and

WHEREAS, a petition has been submitted to Greenville County Council by the majority of owners of fee simple title of the following parcels of real property located in Greenville County to have said property annexed into and made a part of the Greater Greenville Sanitation District, a copy of maps showing the follow parcels is attached hereto as *Exhibit A*:

WHEREAS, Greenville County Council finds that it is in the public interest that the boundaries of the District be enlarged so as to include the properties described above and appearing on *Exhibit A*.
