#### Item (8) ORDINANCES – SECOND READING

#### (a) Zoning Ordinances

- 1. CZ-2013-2, Property of Reichert Consulting LLC located on Blacks Drive requesting rezoning from R-20 to FRD with conditions. The Planning Commission recommended approval and the Committee recommended approval with conditions.
- **ACTION:** On behalf of the Committee, Councilor Dill moved approval of the ordinance at second reading as it was amended on March 19<sup>th</sup>.

Councilor Kirven stated during the previous meeting he spoke on the advantages of the Flexible Review District (FRD) in comparison to R-20. He stated a FRD was a good tool for the County. He questioned how the proposed development would affect the surrounding neighborhoods. Councilor Kirven stated it was not the intent of planning and zoning ordinances to significantly change the established character of a neighborhood. He stated there was overwhelming opposition to the proposed zoning change. As a result of his expanded view and thoughts on the matter, he would not force a neighborhood to change; therefore, he stated he would vote against the proposed zoning change.

Chairman Taylor passed the gavel to Councilor Meadows.

Chairman Taylor referred to the Zoning Ordinance by reading specific factors which would be determined by the Planning Staff before a recommendation was made to the Planning Commission. Based on the list of facts outlined in the Zoning Ordinance, he stated he would vote in opposition to the proposed zoning change.

Councilor Meadows returned the gavel to Chairman Taylor.

Councilor Cates stated the homes were well built and maintained. He stated the proposed zoning change was not appropriate for the specific neighborhood.

Motion, as presented, was denied by a roll call vote of five in favor (Gibson, Rawls, Payne, Dill, Baldwin), six in opposition (Norris, Kirven, Meadows, Cates, Burns, Taylor) and one absent (Seman).

# **ORDINANCES – FIRST READING**

# (a) Adoption of the Administrative Portions of the Collective Building Codes; Associated Appendix; Property Maintenance and Swimming Pool Codes

Councilor Payne presented for first reading an ordinance to comply with the directives of the South Carolina Building Codes Council by repealing Ordinance Number 4198 and adopting the Administrative Provisions (Chapter 1) of the various codes promulgated by the South Carolina Building Codes Council relating to design review and inspection activities of the

County of Greenville and enforcement of building provisions as provided in said codes; and, an ordinance to adopt the Property Maintenance Code, the Standard Swimming Pool Code and existing Building Code in Greenville County as authorized by the South Carolina Building Codes Council; and to adopt certain appendices of the adopted codes to recognize certain variations in the codes based on physical conditions found within Greenville County; and further, to repeal Ordinance Number 3440 to establish procedures, areas, authorities, and rules for the Greenville County Codes Department relating to code enforcement. And repeal Ordinances Numbers 178, 325, and 376; and further, to repeal Ordinance Number 4288 to comply with the directives of the South Carolina Building Codes Council to implement the National Electrical Code, 2008 Edition, as published by the National Fire Protection Association; and to adopt the necessary provisions to administer and enforce this regulatory code in the County of Greenville.

Chairman Taylor stated the item would remain on the floor until second reading.

#### (b) Donation Box Requirements

Councilor Payne presented for first reading an ordinance requiring a person or entity locating a receptacle in Greenville County for donated clothing, footwear or household goods, to clearly display certain information on the receptacle.

Chairman Taylor stated the item would remain on the floor until second reading.
