APPLICATION FOR COUNCIL GRANT ASSISTANCE WITH LIFE SAFETY WATER LINE INSTALLATION

Applications will be based on health and life safety issues that include contaminated/non-potable wells, dry wells and fire protection. Greenville County Public Works Department, Engineering Division, will take applications for Council Grant Assistance with Life Safety Water Line Installation. Applications will be reviewed and scored by the Facilities Project Manager, Assistant County Administrator for Public Works, and the Engineering Division for completeness and criteria and will be submitted to Public Works, Planning and Development Committee for consideration on a first come, first serve basis.

This is a 50/50 grant program; therefore, the County of Greenville, upon approval by County Council, will provide 50% and the applicant will provide the other 50% for the installation of the water main and/or fire hydrant down the public road. The applicant has 60 days to secure their portion of the funding and remit to the County of Greenville. The respective property owners are responsible for the tap/meter fee and connection to the dwelling.

Dear Ms. Davis:

This refers to your request for an estimate for a water main extension to serve the above-referenced property.

According to our measurements, a water main could be extended 700 feet along Manchester Avenue to serve the property. Our extension policy requires that the requesting party finance a portion of the project cost at \$20.00 per foot under our standard Reimbursement Agreement. Accordingly, your portion of the project cost would be 700 feet at \$20.00 per foot for a total of \$14,000.00.

In addition to the cost of the main extension, the requesting party must pay standard connection fees to the Greenville Water System (see attached "Schedule of Fees and Charges" and "Notice to Our Customers") and all applicable plumbers' fees.

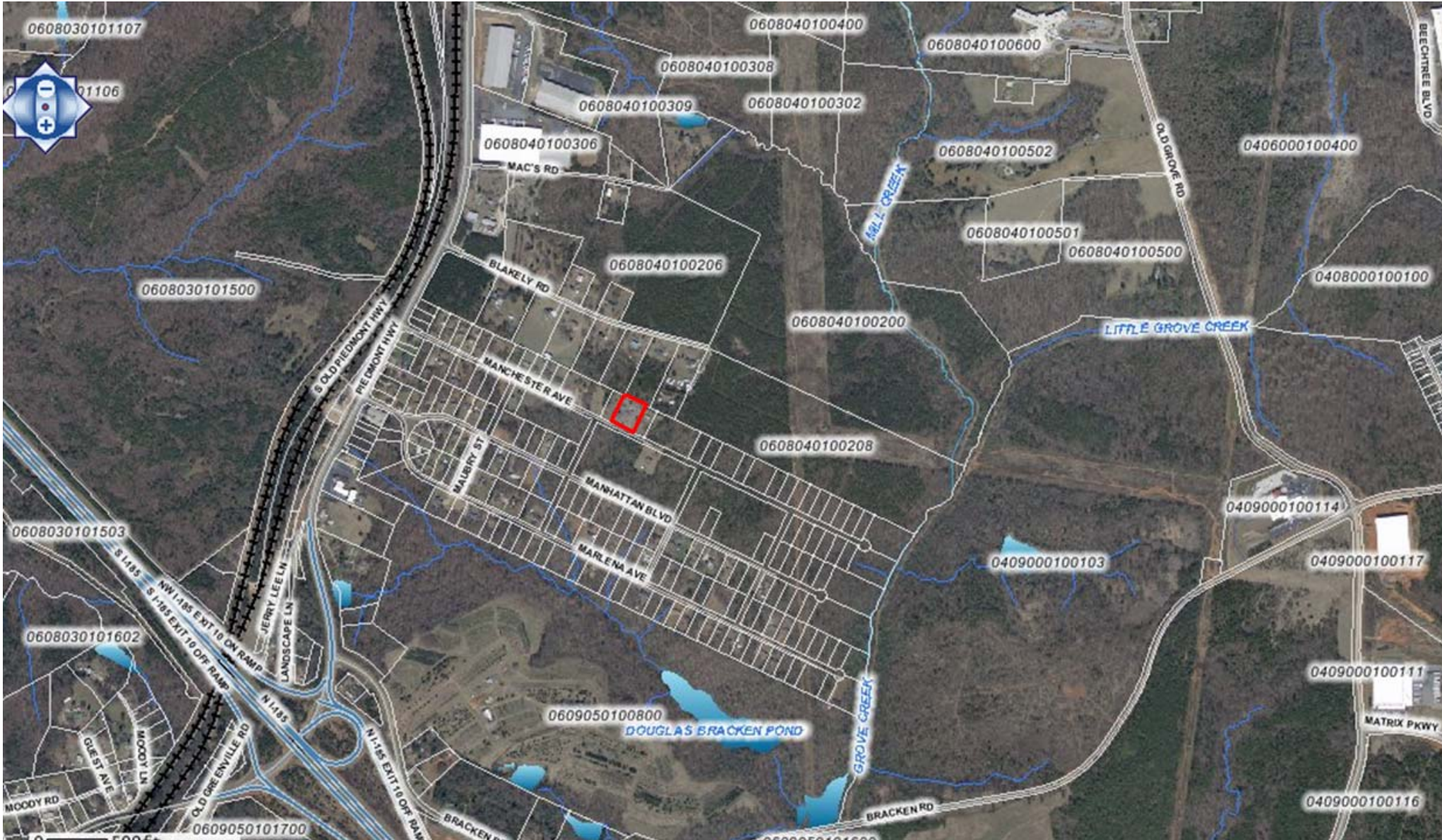



The Piedmont Fire Department received a request from Gwendolyn Davis of 135 Manchester Avenue of Piedmont asking for assistance in getting the public water line extended down her road. After looking into the matter further, we have determined that the extension of this water line would not only bring potable water to the residences in this affected area but would also promote better life safety by bringing a static water source to the homes. Currently, the closet hydrant to the area is approximately 1000 feet away. The extension of the water line with the possibility of an additional hydrant would greatly aid in fire suppression if the need arose. The fire department supports the effort to extend the water line down Manchester Avenue and would greatly appreciate any assistance your department can provide.
