Motion carried unanimously.

(d) Fire District Operating Millage Referendum

ACTION: Councilor Meadows moved for approval at second reading an ordinance to provide a process whereby certain County-created fire districts and certain State-created fire districts may conduct operating millage referenda; and other matters related thereto.

Chairman Taylor thanked the Fire District Financing Ad Hoc Committee for their efforts and dedication in producing the proposed ordinance.

AMENDMENT: Councilor Dill moved to amend the proposed ordinance by inserting verbiage mandating a referendum to allow for a tax increase.

Councilor Kirven stated the proposed ordinance was an effort to give fire districts the opportunity to have better finance management and it would also add an incentive to minimize requests made to County Council for increases in millage.

Councilor Dill stated the verbiage in the proposed ordinance stated the County would pay for the cost of the referendum for a permanent millage.

Councilor Meadows stated the Committee of the Whole discussed having a referendum to allow the residents the opportunity to vote to determine whether or not they wanted a one-cent sales tax to fund road projects. He stated it was the same concept for the fire districts. Residents should make the decision if their taxes would be increased.

Councilor Burns stated a referendum would cost the County more than a fire district proposing a specified amount to County Council. He stated restricting increases to "by referendum only" was removing some of the responsibility from County Council, which he did not agree with.

Councilor Seman stated the proposed ordinance was presented after a lot of hard work and discussions from the ad hoc committee and fire districts.

Councilor Baldwin asked when the election would be held.

Mr. Tollison stated the election would occur in the odd year of the General Election.

Councilor Kirven stated the proposed ordinance would set a procedure, as well as planning and financial management. He urged County Council to approve the proposed ordinance.

Councilor Gibson called for the question.

Motion to amend was denied by a roll call vote of three in favor (Dill, Baldwin, Meadows) and nine in opposition (Taylor, Gibson, Norris, Rawls, Seman, Kirven, Payne, Cates, Burns).

Motion as presented carried unanimously by a roll call vote.

(e) Lease Agreement / University of South Carolina – Children's Law Center

ACTION: Councilor Meadows moved for approval at second reading an ordinance to authorize and direct the Chairman of County Council and the County Administrator to execute a lease with the University of South Carolina – Children's Law Center for the use of available office space at County Square.

(b) Open Application Process for Two Newly Developed Boards / and / Residency Seat Number 1 on the Greenville Technical College Area Commission

ACTION: Councilor Meadows moved to waive the timeline under the County's Boards and Commissions Policy in order for County Council to proceed with the process to fill the vacancies on two newly created boards -- the Greenville County Disabilities and Special Needs Board of Directors and the Lake Forest Special Tax District Commission.

Motion carried unanimously.

ACTION: Councilor Meadows moved to open the application process for 30 days in order to fill the vacancies on two newly created boards; the Greenville County Disabilities and Special Needs Board of Directors and the Lake Forest Special Tax District Commission.

Motion carried unanimously.

ACTION: Councilor Meadows moved to open an application period for two weeks for the now vacant Greenville Tech Commission / Residency Seat Number 1, which is a shared, jointly represented Board and eligible for an application process at this time.
