COMMUNITY PROJECT APPLICATIONS:

PIEDMONT PARK FIRE DISTRICT:

This is a community project application from the Piedmont Park Fire District in the amount of \$2,533.40. The funds will be used to purchase air monitoring equipment.

SLATER MARIETTA FIRE DEPARMENT:
