PUBLIC HEARINGS

(a) **Proposed Relinquishment of a Portion of Park Avenue (K0062)**

A public hearing was held for the purpose of receiving public comments regarding an ordinance relinquishing a 1,724 sq. ft. section of Park Avenue, adjacent to Tax Map Number 0506060100145 for the purpose of allowing the property owner to construct an asphalt turnaround consisting of approximately 2,300 sq. ft. and deed the parcel back to the County for maintenance.

(b) Transfer Surplus Right-of-Way / Bryson Street and Virginia Avenue Alley

A public hearing was held for the purpose of receiving public comments regarding an ordinance to authorize and approve the conveyance of surplus right of way consisting of a 10 ft. wide alley running between Bryson Street and Virginia Avenue, and to authorize and direct the Chairman of County Council and the County Administrator to execute Quitclaim Deeds related thereto.

(a) Precision Valve Corporation / Fee-in-Lieu-of-Tax Agreement Amendment

- ACTION: Councilor Meadows moved for adoption at third reading an ordinance authorizing the execution and delivery of a First Amendment to Inducement Agreement and Millage Rate Agreement dated November 21, 2006 and Fee in Lieu of Tax Agreement between Greenville County, South Carolina and Precision Valve Corporation dated May 20, 2008 and other related matters.

Motion carried unanimously by all County Council Members present.

- 2. **CZ-2013-48**, Property of David Sarkela located on E. Coleman Road, Roberts Circle and River Road, requesting rezoning from R-S to R-15. The Planning Commission and Committee recommended approval.
- **ACTION:** On behalf of the Committee, Councilor Dill moved approval of the ordinance at second reading.

Motion carried unanimously by all County Council Members present.

(b) Text Amendment to Permit Chickens in all Zoned Areas (CZ-2013-37)

ACTION: On behalf of the Committee, Councilor Dill moved for approval at second reading an ordinance to amend Article 4 Definitions, Table 6.1 Uses Permitted, and Section 6:2 Use Conditions of the Greenville County Zoning Ordinance, relating to Permitted Conditional Uses. The Planning Commission and Committee recommended approval of the ordinance.

AMENDMENT: Councilor Meadows moved to allow for amendments at third reading.

Motion to amend carried unanimously by all County Council Members present.

COMMITTEE REPORTS

(a) Committee of the Whole

1. Alcohol and Drug Abuse Commission / Three-Year Strategic Plan

ACTION: On behalf of the Committee, Councilor Meadows moved to accept the 3-year Strategic Plan as presented by the Alcohol and Drug Abuse Commission and to explore opportunities through the Legislative Delegation to obtain additional funding for Commission programs.

Motion carried unanimously by all County Council Members present.

2. Resolution Adding Nineteenth Member to Serve as Chairperson on the Greenville Citizen Roads Advisory Commission

ACTION: On behalf of the Committee, Councilor Meadows moved for adoption a resolution to add a nineteenth non-voting member to the Greenville Citizen Roads Advisory Commission, to appoint the nineteenth member to serve as the Chairperson of the Commission and to cast tie breaking votes.

Councilor Dill expressed his concern with having the language "non-voting" member and then allowing them a tie-breaker vote. He asked if the language could be removed regarding them being allowed to vote at all. He stated this board was created to be a consensus builder. If they were divided on an issue, then the community was going to be divided on the issue.

Chairman Taylor suggested someone include the verbiage stating a tie vote would fail, which was how they, as County Council, conducted their business.

AMENDMENT: Councilor Cates moved to delete the language allowing the nineteenth member to vote as a tie-breaker, and to state in the resolution that a tie-vote fails.

Motion to amend carried unanimously by all County Council Members present.

Motion as amended carried with Councilor Meadows voting in opposition.
