AN ORDINANCE

TO AUTHORIZE AND APPROVE THE CONVEYANCE OF APPROXIMATELY 12.08 ACRES OF COUNTY OWNED REAL PROPERTY INCLUDING HOLIDAY LAKE AND HOLIDAY LAKE DAM, AND TO DIRECT THE CHAIRMAN OF COUNTY COUNCIL AND THE COUNTY ADMINISTRATOR TO EXECUTE APPROPRIATE DEEDS AND AGREEMENTS RELATED THERETO.

WHEREAS, Greenville County Council finds that real property consisting of approximately 12.08 acres including Holiday Lake and Holiday Lake Dam and identified as Greenville County Tax Map Number 0679040100301 (the "Property") was conveyed to the Greenville County Recreation District (the "District") when the District operated Camp Spearhead at its former location which was adjacent to the Property;

WHEREAS, as a condition of the conveyance of the Property to the District, the District agreed to donate the Property in the event it ceased to operate Camp Spearhead at its then current location, and years ago Camp Spearhead was relocated to a new site that has no relation to the Property;

WHEREAS, Greenville County became the owner of the Property when the District was dissolved and its assets and liabilities were assumed by Greenville County, and adoption of this ordinance will allow the County to follow through on the District's obligation to release this property that was triggered when Camp Spearhead was relocated to its current location.

BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:

Section 1. Approval of Conveyance. There is hereby approved the conveyance of approximately 12.08 acres of County owned real property including Holiday Lake and Holiday Lake Dam to Blue Wall Centre, LLC. A complete description of the Property is attached hereto as *Exhibit A*.

Section 2. Authorization to Execute Appropriate Deed and Agreements. The Chairman of Greenville County Council and the County Administrator are hereby authorized and directed to execute any appropriate deeds and agreements necessary to convey the Property to Blue Wall Centre, LLC.

Section 3. Effective Date. This ordinance shall take effect upon the date of its adoption.
