

I would like to introduce myself and tell you a little bit about me. My name is Zoila Mirella Lopez, and I have been a resident of Greenville for eighteen years. I do reside in the Greater Greenville Sanitation District, and I am familiar with the services that they provide to the citizens of Greenville County (both City and County and out-of-district).

I am employed with the City of Greenville Police Department as a Police Officer III. I have been a Police Officer for ten (10) years. As part of my regular Police duties, I also perform the following tasks:

- a) I was assigned as a liaison for the Police Department's Parking Services Division; City Hall's Greenville Cares office; Graffiti division; and the Downtown Merchants Association.
