## A RESOLUTION

TO CERTIFY A PETITION CALLING FOR A POPULAR REFERENDUM TO DETERMINE IF THE BRUTONTOWN SPECIAL TAX DISTRICT SHALL BE CREATED TO PROVIDE FOR STREET LIGHTING WITHIN THE PROPOSED DISTRICT, TO DIRECT THE GREENVILLE COUNTY ELECTION COMMISSION TO HOLD AN ELECTION AND CERTIFY THE RESULTS OF THE ELECTION TO COUNTY COUNCIL.

**WHEREAS**, Greenville County Council has received a petition signed by individuals registered to vote within the proposed Brutontown Special Tax District (the "District") requesting that County Council call for an election to determine whether the District should be created for the purpose of providing street lighting;

**WHEREAS**, pursuant to Section 4-9-30(5)(a)(i) of the South Carolina Code of Laws ("S.C. Code Ann."),

When fifteen percent of the electors in a proposed special tax district sign and present to the county council a petition requesting the creation of a special tax district, an election must be held in which a majority of the electors in that area voting in the election shall approve the creation of the special tax district, the nature of the services to be rendered and the maximum level of taxes or user service charges, or both, authorized to be levied and collected. The petition must contain a description of the proposed special tax district, the elector's signature and address. If the county council finds that the petition has been signed by fifteen percent or more of the electors resident within the area of the proposed special tax district, it may certify that fact to the county election commission.

**WHEREAS**, the costs of the street lighting within the District is to be funded by annual fees on all real property within the District based upon a classification of "improved property" or "unimproved property";

**WHEREAS**, the annual fee on "improved property" will be \$50.00 and on "unimproved property" will be \$25.00;

**WHEREAS**, "improved property" will include any real property with either a residential, commercial, and/or institutional structure on it; all other real property will be classified as "unimproved property";

**WHEREAS**, "unimproved property" may be reclassified as "improved property" when a residential, commercial, and/or institutional structure is built upon it; and

**WHEREAS**, County Council hereby certifies that at least fifteen percent (15%) of the electors residing within the District have submitted a petition to County Council meeting the requirements of S.C. Code Ann. § 4-9-30(5)(a)(i).

**NOW THEREFORE, BE IT RESOLVED** that County Council hereby directs the Greenville County Election Commission to conduct an election on Tuesday, May 6, 2014 within the District on the following question:

(1) Do you favor the creation of a special tax district, to be called the Brutontown Special Tax District, for the purpose of providing street lighting within the proposed district, and do you favor the imposition of an annual fee of \$50.00 on all improved real property located within the district and an annual fee of \$25.00 on all unimproved real property located within the district in order to provide sufficient annual revenue to fulfill the purpose for which the district is to be created?
