BOARDS AND COMMISSIONS:

ACCOMMODATIONS TAX ADVISORY COMMITTEE:

The Accommodations Tax Advisory Committee has five (5) vacancies and received applications from Penny Cooper, Michael Heater, Joyce McCarrell and Alan Strozier.

LAURENS ROAD ARMORY:

The City of Greenville is proposing to develop the Laurens Road Armory property. John Castile, City Manager gave a presentation on the plans by the City of Greenville for the Laurens Road Armory property. The presentation was accepted as information and no action was taken.

Representatives of the Cancer Survivor Park were present to give the committee an updated overview of the proposed park.

Councilor Norris moved to approve and forward to full council an ordinance authorizing the execution and delivery of a Fee In Lieu of Tax Arrangement between Greenville County and Project Orange and inclusion into a Multi-County Industrial Business Park. The motion carried unanimously.

Councilor Norris moved to approve an ordinance authorizing and providing the transfer of County owned properties located near U.S. 25 (Augusta Road) and I-185 commonly known as the Matrix Business & Technology Park, and to authorize the execution of a deed and any other appropriate documents and agreements related thereto. The motion carried unanimously.
