Item (4) ENVISION UPSTATE SC PRESENTATION TO COUNTY COUNCIL

Presented by: Fred Cartwright, Executive Director

Clemson University's International Center for Automotive Research (CU-ICAR).

- Presentation explored how the automotive and transportation industry was changing and how Clemson University and CUICAR were meeting those challenges.
- 5 major changes:
 - More battery operated vehicles
 - Lightweight materials
 - Rapid advances in connected vehicles
 - Shifts in mobility preferences
 - Emergence of autonomous vehicles
- Automotive Industry was a \$2 trillion business in the United States
- Envision Greenville Goals
 - o Intelligent Transportation
 - Vibrant Bus System
 - o Multi-Modal Connectivity
 - Smart Mobility Hubs
 - Automated Transportation Network (ATN) Technology
- Automated Vehicle-Automation Levels
 - No automation
 - o Driver assistance
 - o Partial assistance
 - o Conditional automation
 - o High automation
 - o Full automation
- Cyber security was an issue to prevent a "hacker" from taking control of an automated vehicle
- Need to work with city and county partners
- Significant changes in infrastructure needed
- Project Focus 5 years
 - o Connected, multi-modal transportation
 - Smarter GreenVillages Development
 - Smarter, electric cars and bus transit, mobility hubs, street and traffic light sensors, etc.
 - More bike and pedestrian-friendly pathways
 - Assisted or Automated LSEV shuttles (aTaxis)
 - Verdae
 - City View / Legacy Charter School
 - Automated Transit Network (ATN) system
 - GSP Airport (2016 RFP for 2017-18 completion)
 - Greenville Urban Corridors
 - Clemson Urban Corridors
- Transportation changing quickly
- Move toward sustainable forms of mobility would happen in cities around the world
- Large sectors of the US economy are affected with many inherent risks

- Federal Government announced \$4 billion budget for FY2017 related to automated vehicles
- The knowledge and resources of Greenville and the Upstate have an unprecedented opportunity to lead the way
 - o In order to compete, must get in the game
 - Begin by stating the Council's support via the proposed resolution

Chairman Taylor stated both Spartanburg and Greenville Counties have large carbon fiber manufacturers. He added carbon fiber was used in the aviation industry but considered expensive for the automotive industry. Chairman Taylor asked if that had changed and would those manufacturers be considered a source of construction materials for automobiles.

Mr. Cartwright shared that Doug Webster was instrumental in the process along with Councilor Fred Payne and others in compiling the necessary information. He added that Greenville did not win but it was a good step forward. Mr. Cartwright stated 78 cities competed and there were now five finalists.

Councilor Ballard asked if Greenville was chosen to receive a grant, would the grant be available for review before acceptance by the County. He stated he had reviewed possible grants and some appeared to come with heavy strings attached, including local government bodies losing control to federal agencies. Councilor Ballard stated Greenville County would not want to agree to a grant and then lose governing control because of the terms of the grant.

Councilor Burns stated Council had been presented with Resolutions in the past asking for support for various opportunities. He asked what would be expected in terms of support if Greenville County was chosen for this type of grant. Councilor Burns stated Council certainly wanted to be supportive of an effort but needed to know what that support meant. He asked what exactly was County Council being asked to support and in what ways.

Mr. Cartwright stated he came to the meeting with a proposed Resolution but did not feel it answered Council's questions. He stated his presentation was intended to be a way to gain a consensus for CUICAR and Greenville County to establish a private / public partnership to help define what was needed to be done.

Councilor Payne stated there were many challenges to be faced in applying for grants. He added all federal grants require some type of matching funds. Councilor Payne stated all entities involved needed to organize and work together. He stated if there was no effort to step up and get involved, other communities and universities would take advantage of the opportunities and Greenville County would lose out. Councilor Payne requested Doug Webster address Council.

Doug Webster stated he worked for CBRE Real Estate and was often approached by his counterparts requesting information about the Greenville area in regards to major corporations and site selection. He added mobility and transportation were factors when a major corporation chose a site, along with quality of life, community connection, etc. Mr. Webster stated those inquiries were an opportunity to talk about assets in Greenville County such as CUICAR, ITIC, and Proterra. He stated organization and support were needed to be successful in order to recruit and gain available assets. Mr. Webster stated he felt the proposed Resolution should state Greenville County Council supported the ability for CUICAR to pursue research and development as well as supported Greenville County in looking at multi-level transportation and other methods of transportation.
