It is with pleasure that I submit to you for nominations as Animal Control Officer, Daniel Custer and Code Enforcement Officers, Mollie Davidson, Bill Girard, Heath Gregory, David Martin, Dean Miles and Eric Vinson.

Daniel Custer is an Animal Control Officer and has completed Sheriffs Office Weapons Training, Emergency Vehicle Driver Training and Animal Control Cruelty School in Anderson, SC. He has been employed as an Animal Control Officer since June 8, 2015.

Mollie Davidson is a Code Enforcement Officer where she investigates complaints of Building, and Property Maintenance regulations.
