#### (e) Hospitality Tax Refunding COPs Series 2016

#### ACTION:

Councilor Kirven moved for adoption at third reading an ordinance authorizing Greenville County, South Carolina, to execute documents including a third supplement to lease agreement by and between Greenville County, South Carolina and Greenville County Tourism Public Facilities Corporation; consenting to the issuance of refunding Certificates of Participation in the third supplement to lease agreement in the aggregate principal amount of not exceeding \$10,100,000; approving the form of a third supplement to trust agreement between Greenville County Tourism Public Facilities Corporation and the Trustee named thereunder; authorizing a pledge of and lien on the Hospitality Tax revenues to secure the payment of the lease rentals under the lease agreement; and other matters relating thereto.

Motion carried unanimously by Council Members present.

#### Item (9) ORDINANCES – SECOND READING

#### (a) Zoning Ordinance

# 1. CZ-2016-48:

Property of Virginia C. Taylor, located on Dublin Road, requesting rezoning from R-S to S-1.

The Planning Commission recommended denial and the Committee had no recommendation.

#### ACTION:

On behalf of the Committee, Councilor Dill moved approval of the ordinance at second reading.

Councilor Burns stated the property was located in his district and he was very torn about the request. The applicant had requested S-1; however, the property was in the middle of R-S zoned lands and fronts Interstate 85. Councilor Burns stated Dublin Road and Muddy Ford Road were problematic due to high volumes of traffic. He added that part of Dublin Road was maintained by SC DOT and the other part was maintained by Greenville County. Councilor Burns stated even though the property was zoned R-S, no one would be willing to purchase the property and build single-family homes. He added other factors which influenced the zoning of the property included the proximity to Interstate 85 and the widening project currently in progress, along with the 140,000 cars that pass by on a daily basis. Councilor Burns suggested Council approve the request and then study it in greater detail, prior to third reading.

Councilor Baldwin asked what the Long Range Plan called for in regards to the property.

Councilor Burns stated the Long Range Plan maintained the property's zoning at R-S. He stated the highway was built in the early 1960's and the property was not zoned until the early 1970's.

Chairman Taylor inquired about the elevations of the property in relation to Interstate 85.

Councilor Burns stated the back of the property was slightly elevated above Interstate 85 but the part along Muddy Ford Road was lower than the highway.

Councilor Meadows stated he agreed the request was very difficult. He stated Imagine Greenville stipulated R-S zoning for the property. Councilor Meadows stated many homes had been built in the area and to rezone the property in question as S-1 would be a travesty.

Councilor Seman stated the quality of the road and the truck traffic could not be ignored.

Councilor Norris stated Council needed to be supportive of the residential areas already established in the area.

Councilor Payne stated the rights of the property owner should be respected, but the rights of the existing community should be respected as well.

Councilor Kirven stated the power to approve or deny zoning requests should be used beneficially rather than punitively, for all the citizens involved. He stated he hoped the company interested in using the property would build a structure that was in line with the surrounding properties.

**ACTION:** 

Councilor Payne moved to hold the item until the next regularly scheduled County Council meeting to be held on October 18, 2016.

Motion to hold approved by a vote of ten (Dill, Baldwin, Meadows, Cates, Burns, Taylor, Seman, Ballard, Kirven and Payne) in favor and one (Norris) in opposition.

Councilor Kirven moved for approval at second reading an ordinance to repeal the Greenville County Alcohol and Drug Policy adopted pursuant to Ordinance No. 3594; and to provide that adoption of future alcohol and drug policies, and any amendment thereto, shall be by resolution.

#### Item (13) ADMINISTRATOR'S REPORT

The Governor has declared a state of emergency due to Hurricane Matthew; along with people, come their pets. Greenville County Animal Care will serve as a primary pet shelter for those Charleston County residents who have been evacuated from the coast. Greenville County is prepared to host more than 400 animals. In order to serve the County's residents and visitors, Animal Care is suspending all regular daily activities. Those with appointments at the Wellness Clinic have been notified. Adoptions and all regular services will resume on Monday, October 10th. Basically, Animal Care will be closed to the general public until then.

#### Item (14) REQUESTS AND MOTIONS BY COUNCIL MEMBERS

- Councilor Payne addressed some of the concerns people had regarding Land Development Regulations. Many citizens have complained that they were not given enough opportunities for input, but Mr. Payne felt the process was not fully understood. He explained the process brought in informed citizens and encouraged them to debate with each other in order to reach conclusions, which were then reviewed by the Planning Commission. He felt the process was very thorough and that staff as well as citizens had ample opportunities to move the matter forward.
- Councilor Dill stated Saturday morning, October 8th, they were going up on Hogback Mountain to clean the Lindsay Pittman, Emery graveyard. Anyone who wanted to help needed to be at the entrance of the Cliffs of Glassy at 10:00 Saturday morning.
- Councilor Baldwin asked if the Travelers Rest Magistrate's office opened on the 3rd
  of October. Mr. Kernell stated it did open and they were moved in over the
  weekend. Mr. Dill stated there would be a ribbon cutting.
- Councilor Meadows expressed his appreciation to the Codes staff. He stated often times they were not recognized for the work they do. He stated many worked over the past weekend cleaning up a lot of the violations and problems that exist in Greenville County.
- Councilor Norris stated Brandon Mill was coming along nicely. She has hopes for the Monaghan Mill and for the unseen areas that she has talked about.
- Councilor Seman stated the SCTAC Board of Directors, on behalf of Greenville County and the City of Greenville, were honored to host USDOT Secretary Anthony Foxx for a visit to the International Transportation Innovation Center last Friday to observe examples of the latest road safety and charging technology for automated, sustainable and connected vehicles. Nearly 150 elected officials, industry partners and special guests were in attendance as Secretary Foxx addressed the gathering and participated in demonstrations focused on sensor-based roadside safety systems; camera-based vehicle side collision avoidance systems; and in-motion wireless power transfer supported by a cyber secure communications infrastructure. The technology demonstrations were orchestrated by ITIC Chief Technology Officer Dr. Joachim Taiber and supported by BMW, Cisco, Duke Energy, Mobileye, Oakridge National Laboratory, Proterra and Toyota. She thanked everyone that was able to come out.

- Councilor Ballard thanked the local responders in Greenville who sent people down to help out in Townville. Many of the emergency departments sent men and equipment down while Townville was dealing with the situation they had before them. He stated the South Greenville Fire Department, on South Augusta Road, was having their "Safety Day" on Saturday, October 8th, from 10:00 until 2:00. He stated on Friday, he was honored to attend the swearing in ceremony of the new Probate Judge, Judge Weigle. Mr. Ballard announced on Wednesday, October 5th, there would be a farewell gathering for Charlie Garrett, who was retiring.
- Councilor Ballard wished Joe Dill and Bob Taylor a Happy Birthday.
