# **APPROVAL OF MINUTES:**

### FY2017 LOCAL EMERGENCY MANAGEMENT PEROFRMANCE:

This is the FY2017 Local Emergency Management Performance Grant in the amount of \$344,308. The grant will fund contractual services (cellular telephone services), travel expenses (Emergency Management Workshops) and various equipment and supplies (vehicle, mobile command post upgrades and computer equipment). The County's in-kind match will come from budgeted salaries and benefits in the Emergency Management Division (Sheriff's Office).

Ruth Parris, Budget Manager and Jay Merritt, Emergency Management were present to answer questions of the committee.

Councilor Kirven moved to approve the FY2017 Local Emergency Management Performance Grant in the amount of \$344,308. The motion carried unanimously.

### **PETCO FOUNDATION GRANT:**

This is the Petco Foundation Grant – Innovation Showdown in the amount of \$5,000. The funding will be used by Animal Care Services to purchase Go Pro cameras and the development of educational video blogs that can be shared among animal welfare professionals. This grant does not require a County match.

Ruth Parris, Budget Manager and Shelley Simmons, Animal Care were present to answer questions of the committee.

Councilor Cates moved to approve the Petco Foundation Grant in the amount of \$5,000. The motion carried unanimously.

### FY2017 JUSTICE ASSISTANCE GRANT:

This is the 2017 Justice Assistance Grant Program in the amount of \$163,164. The grant will fund public safety, law enforcement, and judicial support programs with the objective of enhancing and continuing programs established by the Sheriff's Office, Public Safety Department and the Circuit Solicitor's Office. This grant does not require a County match.

Ruth Parris, Budget Manager, Jackie Kellett, Forensics, and Jinny Moran, Public Safety were present to answer questions of the committee.

Councilor Norris moved to approve the 2017 Justice Assistance Grant Program in the amount of \$163,164. The motion carried unanimously.

### JEDA BONDS – ST. FRANCIS HOSPITAL/BON SECOURS HEALTH SYSTEM:

This is a resolution in support of the issuance by the South Carolina Jobs-Economic Development Authority of its economic Development Refunding Revenue Bonds for Bon Secours Health System, Inc. in an amount not exceeding \$69,925,000.
