APPROVAL OF MINUTES:

Councilor Seman moved to approve the minutes of the regular meeting of September 11, 2017. The motion carried unanimously.

Greenville County Council Committee on Finance

SC PARK AND RECREATION DEVELOPMENT FUND GRANT:

This is the SC Park and Recreation Development Fund Grant in the amount of \$71,140.64. The grant will allow the Parks, Recreation and Tourism Department to provide improvements to Monaghan Park, which include renovating restrooms improving parking and making the amenities ADA compliant. The Parks, Recreation and Tourism Department will match the grant with \$43,859.35 to complete the project at a total cost of \$115,000.

Ruth Parris, Budget Manager and Gene Smith, Executive Director of Parks & Recreation, were present to answer questions of the committee.

Councilor Seman moved to approve the SC Park and Recreation Development Fund Grant in the amount of \$71,140.64. The motion carried unanimously.

FY2016 HOMELAND SECURITY GRANT – BOMB TEAM:

This is the FY2016 Homeland Security Grant on the amount of \$5,000. This grant will allow the Sheriff's Office to provide bomb handling equipment and scene lights. This grant does not require a County match.

Ruth Parris, Budget Manager and Jeff Ward, Sheriff's Office were present to answer questions of the committee.

Councilor Norris moved to approve the FY2016 Homeland Security Grant – Bomb Team in the amount of \$5,000. The motion carried unanimously.

FY2016 HOMELAND SECURITY GRANT - SWAT:

This is the FY2016 Homeland Security Grant – SWAT Team in the amount of \$24,000. The grant would allow the Sheriff's Office to acquire SWAT personal protective equipment suits and filters. This grant does not require a County match.

Ruth Parris, Budget Manager and Jeff Ward, Sheriff's Office were present to answer question of the committee.

Councilor Cates moved to approve the FY2016 Homeland Security Grant – SWAT Team in the amount of \$24,000. The motion carried unanimously.
