## Item (4) Relinquishment of 2,382 square feet of Thompson Drive (00099)

She stated the request came from a family that had built their garage slightly into the right of way. It was a very small sliver to relinquish to enable their property to be free and clear.

Ms. Gamble stated there was no way of knowing where to look for the roads.

Mr. Dill stated it was up to the owner to check their property line.
