Greenville County Recreation District is requesting approval of a grant submission to the South Carolina Department of Parks, Recreation and Tourism for the Recreational Trails Program Grant. The grant would be in the amount of \$100,000, having an in kind match of \$25,000. The monies would be used for the construction of the Swamp Rabbit Trail from CU-ICAR to Verdae Boulevard, approximately 4100 feet.

The submittal date for the grant request is March 14, 2018 and the notification of award is expected in late fall of 2018.
