Councilor Seman moved to approve the minutes of the regular meeting of March 12, 2018. The motion carried unanimously.

GRANT APPLICATIONS:

FY2019 GENERAL RECYCLING OPTIONS GRANT:

This is the FY2019 General Recycling Options Grant in the amount of \$25,000. This grant would allow the Solid Waste Division to fund a food scrap collection/recycling structure to be located at the Simpsonville Residential Waste and Recycling Center. Grant funds will also be used for signage, work table, plastic tubs and brochure holders. This grant does not require a County match.

Ruth Parris, Budget Director and Wendy McNatt, Recycling Coordinator were present to answer questions of the committee.

Councilor Norris moved to approve the FY2019 General Recycling Options Grant in the amount of \$25,000. The motion carried unanimously.

FY2019 SOLID WASTE EDUCATION/OUTREACH GRANT:

This is the FY2019 Solid Waste Education/Outreach Grant in the amount of \$25,000. This grant would allow the Solid Waste Division to promote and educate citizens about food scrap recycling/composting programs. Funds will be used for social media costs, billboards, direct mail, post cards, brochures, and three box truck vehicle wraps. This grant does not require a County match.

Ruth Parris, Budget Director and Wendy McNatt, Recycling Coordinator were present to answer questions of the committee.

Councilor Norris moved to approve the FY2019 Solid Waste Education/Outreach Grant in the amount of \$25,000. The motion carried unanimously.

FY2019 USED OIL GRANT:

This is the FY2019 Used Oil Grant in the amount of \$26,785.76. This grant would allow the Solid Waste Division to fund the promotion of the environmental importance of recycling used oil, purchase equipment and supplies, related contractual costs, and professional development costs. This grant does not require a County match.

Ruth Parris, Budget Director and Wendy McNatt, Recycling Coordinator were present to answer questions of the committee.

Councilor Norris moved to approve the FY2019 Used Oil Grant in the amount of \$26,785.76. The motion carried unanimously.

FY2019 WASTE TIRE GRANT:

This is the FY2019 Waste Tire Grant in the amount of \$422,274.96. This grant would fund the Solid Waste Division's contractor costs for current generation tires and provide funds for professional development and public education in the area of waste tire reduction and recycling. Funds would also be used to purchase roll-off collection containers to be used at the seven Residential Waste and Recycling Centers for the collection of used tires from residents. This grant does not require a County match.

FY2019 WASTE TIRE GRANT CON'T:

Ruth Parris, Budget Director and Wendy McNatt, Recycling Coordinator were present to answer questions of the committee.

Councilor Norris moved to approve the FY2019 Waste Tire Grant in the amount of \$422,274.96. The motion carried unanimously.

SOUTH GREENVILLE AREA FIRE DISTRICT - GENERAL OBLIGATION BONDS:

This is an ordinance finding that the South Greenville Area Fire District may issue not exceeding \$3,000,000 in General Obligation Bonds and to authorize the Board of Fire Control of the South Greenville Area Fire District to issue such bonds and a resolution calling for a public hearing to be held upon the guestion of the issuance of not exceeding \$3,000,000.

Chief Taylor, Brad Love, Haynsworth Sinkler Boyd and Teressa Cawley, Financial Advisor were present to answer questions of the committee.

Councilor Cates moved to approve the ordinance and the resolution authorizing the South Greenville Area Fire District to issue General Obligation Bonds in an amount not exceeding \$3,000,000 and to hold a public hearing. The motion carried unanimously.

COMMUNITY PROJECT APPLICATIONS:

CITY OF TRAVELERS REST – PUBLIC ARTWORK – LAODICEA (DICEY) LANGSTON

This is a Community Project Application for the City of Travelers Rest in the amount of \$10,000. The funds will be used to erect a sculpture of Dicey Langston which would complement the City's continued growth.
