## FOOTHILLS FIRE SUPPORT AREA – MILLAGE REQUEST:

The Foothills Fire Service Area is requesting approval of a 9.7 mill increase which represents (a) 0.5 in the FSA's tax rate which equates to a CPI and population growth of 3.69% as allowed per Section 6-1-320(A) of the SC Code of Laws, (b) an increase in the FSA's tax rate of two (2.0) mills for the maintenance of a reserve as allowed per Section 6-1-320(D), and (c) an increase of seven and two-tenths (7.2) mills as allowed per Section 6-1-320 (B) to cover a deficit in the County's contractual obligation to the Town of Tryon.

Richard Locke, Commission Chair was present to answer questions of the committee.

Councilor Seman moved to approve the 9.7 mill increase for the Foothills Fire Service Area to cover a deficit in the County's contractual obligation to the Town of Tryon. The motion carried unanimously.
