APPLICATION FOR COUNCIL GRANT ASSISTANCE WITH LIFE SAFETY WATER LINE INSTALLATION

Applications will be based on health and life safety issues that include contaminated/non-potable wells, dry wells and fire protection. Greenville County Public Works Department, Engineering Division, will take applications for Council Grant Assistance with Life Safety Water Line Installation. Applications will be reviewed and scored by the Facilities Project Manager, Assistant County Administrator for Public Works, and the Engineering Division for completeness and criteria and will be submitted to Public Works, Planning and Development Committee for consideration on a first come, first serve basis.

This is a 50/50 grant program; therefore, the County of Greenville, upon approval by County Council, will provide 50% and the applicant will provide the other 50% for the installation of the water main and/or fire hydrant down the public road. The applicant has 60 days to secure their portion of the funding and remit to the County of Greenville. The respective property owners are responsible for the tap/meter fee and connection to the dwelling.

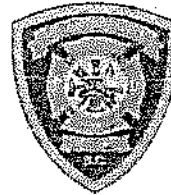


Re: Water Main extension at/near 320 Circle Road

I was asked by the residents, Tripp and Stephanie Atkins of 320 Circle Road, Greer, S.C. to evaluate the current situation from a fire safety standpoint for this location and surrounding area. This section of Circle road, although there is water close by, this address as well as a number of others is well beyond the 1,000 feet distance that is required for adequate fire protection. This puts the fire department into a situation of realistically no feasible public water supply. What that means for us is that in the event of a fire in this area, we would have to shuttle water in to the area from other fire hydrants in the general vicinity. Doing so is a part of our normal operations, but does extend the time and resources to adequately providing fire protection in a fast, efficient manner. The other area of concern is the rates that homeowners pay for property insurance, any are outside 1,000 feet from a public fire hydrant will normally pay a much larger amount of money for their homeowners insurance.

There is no question that the extension of the water main along with the installation of a public fire hydrant would make this a safer and more efficient situation for not only the Atkins residence but several others nearby. We certainly support the idea of doing both.

This refers to your request for an estimate for a water main extension to serve the above referenced property.

According to our measurements, a water main could be extended 1,171 feet along Circle Road to serve the property. The applicant is required to advance funds for a water main installation at \$30 per foot under a standard Installation Agreement with the Commission. Accordingly, your project cost would be 1,171 feet at \$30.00 per foot for a total of \$35,130. Price and policy are subject to change without notice.

In addition to the cost of the main extension, the requesting party must pay standard connection fees to Greenville Water (see <http://www.greenvillewater.com/development-fees/>) and all applicable plumbers' fees.
