Item (3) Executive Session

Action:

Vice-Chairman Meadows moved to go into Executive Session for discussion of negotiations incident to proposed contractual arrangements and proposed sale or purchase of a property, the receipt of legal advice where the legal advice relates to a pending, threatened, or potential claim or other adversary situations involving the assertion against the County of a claim relating to the University Ridge Redevelopment.

Motion carried unanimously and the Committee of the Whole entered Executive Session at 12:10 p.m.

County Attorney Mark Tollison reported the Committee of the Whole out of Executive Session stating no action was taken during that session. The regular Committee of the Whole meeting reconvened at 1:30 p.m.

Item (4) Lease / Purchase of Property at 350 and 352 Halton Road

Action:

Councilor Taylor moved to approve the lease / purchase of the property at 350 and 352 Halton Road and to authorize the negotiation and execution of all necessary agreements to complete the acquision of the property.

Motion was denied by a roll call vote of six (Dill, Cates, Taylor, Seman, Kirven and Tripp) in favor and six (Barnes, Meadows, Roberts, Norris, Fant and Ballard) in opposition.

Action:

Councilor Roberts moved to adjourn the meeting.

Councilor Dill inquired about the future direction of the County Square Project since the motion failed.

Chairman Kirven stated he was unable to answer Mr. Dill's question at this time.

Vice-Chairman Meadows stated the concern was the proposed price of the Halton Road property.

Councilor Dill stated it was his understanding that another piece of property would have to be identified.

Councilor Fant stated that was not the issue.

Councilor Dill inquired at what point would the County Square Project be "killed" or did the denial of the motion automatically "kill" the project.

Chairman Kirven stated he did not see anything clear at this time for the County Square Project.

The meeting was adjourned at 1:33 p.m.
