Councilor Roberts inquired what procedures were in place to deal with individuals who were currently serving on special tax districts and no longer lived in the designated area.

Mark Tollison stated the names should be submitted to the Clerk's office. If they no longer lived in the designated area, the position should be considered a vacancy.

Councilor Roberts asked if a special election would be held to appoint a new member.

Mark Tollison stated a special election could be held if the board lacked a quorum due to the vacancy or had an emergency situation that required immediate attention.

Vice-Chairman Meadows moved to go into Executive Session for the discussion of negotiations incident to proposed contractual arrangements and proposed sale or purchase of property.
