AN ORDINANCE

TO CREATE THE DREXEL TERRACE SPECIAL TAX DISTRICT; TO DEFINE THE BOUNDARIES OF THE DISTRICT AND THE PURPOSE FOR WHICH IT IS CREATED; TO ESTABLISH THE DISTRICT AS AN ADMINISTRATIVE DIVISION OF GREENVILLE COUNTY; AND TO IMPOSE AN ANNUAL FEE OF NOT MORE THAN FORTY-FIVE DOLLARS (\$45.00) ON ALL REAL PROPERTY LOCATED WITHIN THE DISTRICT.

BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:

Section 1. Findings. Pursuant to Section 4-9-30(5)(a)(ii) of the Code of Laws of South Carolina 1976, as amended, seventy-five percent (75%) of the resident freeholders owning seventy-five percent (75%) of the assessed value of the real property in the proposed Drexel Terrace Special Tax District submitted a petition to Greenville County Council requesting that an ordinance be enacted to establish a special tax district for certain purposes hereinafter set forth, and that a maximum uniform service charge not to exceed Forty-Five Dollars (\$45.00) be placed on all real property located within the boundaries of the District. The petition has been verified as meeting the requirements for the formation of a special tax district.

Section 2. Creation of Special Tax District. There is hereby created the Drexel Terrace Special Tax District, the boundaries of which include the properties as shown on *Exhibit* "A" attached hereto.

A copy of a map showing these parcels and the boundaries of the Drexel Terrace Special Tax District is attached hereto as *Exhibit "B"*.

<u>Section 3.</u> <u>Purpose.</u> The purpose and function of the Drexel Terrace Special Tax District herein established shall be as follows:

To provide for the health, safety and welfare of its citizens within the proposed district by funding the costs of street lighting within the district.

- <u>Section 4.</u> <u>Administrative Division of Greenville County.</u> The Drexel Terrace Special Tax District shall be operated as an administrative division of Greenville County.
- Section 5. Uniform Service Charge. The Auditor and Tax Collector of Greenville County are hereby directed to assess and collect a uniform service charge of not more than Forty-Five Dollars (\$45.00) annually on all real property within the Drexel Terrace Special Tax District. All monies collected from this uniform service charge shall be credited to the District.
- <u>Section 6.</u> <u>Contract Rates.</u> The provision of lighting is being acquired by agreement with the electric utility provider in the area. Should utility rates increase, the County may reestablish a new maximum service charge in order to maintain lighting within the District.

Section 7.	Effective Date. This ordinan	ice shall take effect upon its adop	otion.
