### **GREENVILLE COUNTY REDEVELOPTMENT AUTHORITY 2019 ANNUAL ACTION PLAN:**

Greenville County Redevelopment Authority Board and staff is requesting approval of the 2019 Annual Action Plan Budget. Greenville County is required to submit to the U.S. Department of Housing and Urban Development the planned uses of Community Development Block Grant, HOME Investments Partnership and Emergency Solutions Grant (ESG) funds that will be allocated to the County beginning July 1, 2019.
