**SUMMARY:** Since 2017, the Greenville County Planning Department has

worked with a variety of residents and community stakeholders of the City View area to develop the **City View Community Plan**. This work was conducted through a variety of community meetings, Steering Committee meetings, and outreach efforts to solicit input and educate community members on potential development scenarios along with strategies for addressing immediate needs.

The **City View Community Plan** addresses the needs and vision of the community through three core principles: Community Spirit, Community Safety, and Community Development. These principles layout multiple strategies for engaged community members along with recommended development patterns that

reflect the vision of the participants.

**CONCLUSION:** Therefore, staff is requesting that the **City View Community Plan** 

be recommended by resolution and forwarded to County Council for consideration as an amendment to the Imagine Greenville

County Comprehensive Plan.

#### AN ORDINANCE

# AN ORDINANCE TO ADOPT THE CITY VIEW COMMUNITY PLAN AS AN AMENDMENT TO THE IMAGINE GREENVILLE COUNTY COMPREHENSIVE PLAN.

**WHEREAS**, in 2009, Greenville County Council adopted "Imagine Greenville County" as the Greenville County Comprehensive Plan under the authority of the South Carolina Local Government Comprehensive Planning Enabling Act of 1994 (Chapter 29) and in accordance with Section 6-29-510, et seq., of the *Code of Laws of South Carolina*, 1976, as amended; and

**WHEREAS**, the Greenville County Planning Commission has acted pursuant to S. C. Code Ann. 6-29-520(B), by Resolution to recommend that Greenville County Council amend the County's Comprehensive Plan with the adoption of the City View Community Plan, attached hereto and incorporated herein by reference as Exhibit "A", and

**WHEREAS**, several community meetings and public input sessions were held over the past year, at which community residents and community stakeholders worked extensively with Planning staff to develop their vision for the future of the City View Community; and

**WHEREAS**, the City View Community Plan, completed in 2019, was jointly developed by Greenville County and numerous residents and stakeholders,

**NOW, THEREFORE, BE IT ORDAINED** by the Greenville County Council:

### **Section 1.** Adoption of the City View Community Plan.

Greenville County Council hereby adopts the City View Community Plan, as set forth in Exhibit "A" attached hereto, as an amendment to the County's Comprehensive Plan, in accordance with Section 6-29-510, et seq., of the *Code of Laws of South Carolina*, 1976, as amended.
