Item (3) Approval of the Minutes of the Regular Meeting of PWI Committee on June 18, 2019.

Item (4) Commissioning of Code Enforcement Officers

Paula Gucker, Assistant County Administrator introduced Josh Fisher, Chief Inspector and two of his employees. Tommy Lowe, is a Stormwater Quality Inspector and Kevin Jones who is a Construction Inspector. Ms. Gucker requested the Committee to approve and forward their names for full Council for Commissioning.

Item (5) FY2020-FY2021 Road Paving List

Hesha Gamble, County Engineer addressed the Committee with an overview of the road paving list. She explained the county evaluates every road every four years. At that time each road is given a score and from the list staff compiles a road list based on worse-first in each district.

Item (7) Annexation of property into the Metropolitan Sewer Subdistrict – 130 Sweeney Road and 136 Sweeney Road.

MOTION: By Dr. Cates to approve and forward to full Council the request for a Public Hearing, and enlarging the boundaries for annexation into the Metropolitan Sewer Subdistrict, 130 and 136 Sweeney Road. The motion carried by voice vote with one absent (Seman).
