Councilor Meadows provided the invocation.

APPROVAL OF MINUTES:

Councilor Cates moved to approve the minutes of May 11, 2020. The motion carried unanimously.

GRANT APPLICATIONS:

BEST FRIENDS ANIMAL SOCIETY GRANT - RACHEL RAY SAVE THEM ALL COVID 19 RELIEF GRANT:

This is the Best Friends Animal Society Grant – Rachel Ray Save Them All Covid 19 Relief Grant in the amount of \$5,000. The funds will be used by Animal Care Services to promote and expand the County's foster care program. This grant does not require a County match.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Seman moved to approve the Best Friends Animal Society Grant – Rachel Save Them All Covid 19 Relief Grant in the amount of \$5,000. The motion carried unanimously.

MADDIE FUND PET FOSTER CARE STIMULUS GRANT:

This is the Maddie Fund Pet Foster Care Stimulus Grant in the amount of \$5,000. The funds will be used by Animal Care Services to fund life-saving purposes related to the County's pet foster care program. This grant does not require a County match.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Meadows moved to approve the Maddie Fund Pet Foster Care Stimulus Grant in the amount of \$5,000. The motion carried unanimously.

BOILING SPRINGS FIRE DISTRICT - MILLAGE REQUEST:

Boiling Springs Fire District is requesting adoption of a resolution approving a millage increase in the District's tax rate of two (2.0) mills from 27.4 mills to 29.4 mills for operation and maintenance. The requested rate increase represents CPI and population growth and a "lookback" as allowed per Section 6-1-320 (A) of the South Carolina Code of Laws for Fiscal Years 2020 and 2021.

Councilor Meadows recused himself and abstained from voting due to a conflict of interest.

Chief Graham, Taft Matney, William McDowell and Larry Finney representatives of Boiling Springs Fire District were present to answer questions of the committee.

Councilor Kirven moved to approve the millage increase of 2.0 mills for the Boiling Springs Fire District. The motion carried a vote of 5-0, with an abstention from Councilor Meadows.

SOUTH GREENVILLE FIRE DISRICT - MILLAGE REQUEST:

South Greenville Fire requests a 4.8 mill increase in the District's tax rate for operational maintenance which represents CPI and population growth and a three-year lookback as allowed per Section 6-1-320A of the South Carolina Code of Laws.

Chief Sutherland and Teressa Cawley, Financial Advisor were present to answer questions of the committee.

Councilor Seman moved to approve the 4.8 mill increase in the District's tax rate for operational maintenance for South Greenville Fire District. The motion carried unanimously.

CLEAR SPRINGS FIRE DISTRICT – MILLAGE REQUEST:

Clear Springs Fire District is requesting a tax levy of three and four-tenths (3.4) mills from 23.9 to 27.3 which represents CPI and population growth plus a "lookback" of three years as allowed per Section 6-1-320 of the South Carolina Code of Laws.

Councilor Meadows recused himself and abstained from voting due to a conflict of interest.

Chief Huppman, Todd Milan and Larry Finney, representatives of the Clear Spring Fire District were present to answer questions of the committee.

Councilor Kirven moved to approve the millage increase of three and four tenths for the Clear Springs Fire District. The motion carried a vote of 5-0, with an abstention from Councilor Meadows.

CHANTICLEER COMMUNITY SPECIAL TAX DISTRICT MILLAGE REQUEST:

This is an ordinance to provide for the millage increase of two and eight-tenths mills from 11.9 to 14.7 for the Chanticleer Community Special Tax District. The rate increase will raise an additional \$15,000 annually to continue the provision of law enforcement services.

Alan Shusterman, Chairman, Special Tax District was present to answer questions of the committee.

Councilor Seman moved to approve the millage increase of two and eight-tenths. The motion carried unanimously.

GREENVILLE COUNTY GRIEVANCE COMMITTEE POOL:
