## **A RESOLUTION**

TO AUTHORIZE THE GREENVILLE COUNTY REDEVELOPMENT AUTHORITY TO APPLY FOR AND ADMINISTER SUPPLEMENTAL EMERGENCY SOLUTIONS GRANTS (ESG-CV) FUNDING TO PREVENT, PREPARE FOR AND RESPOND TO THE CORONAVIRUS PANDEMIC.

WHEREAS, the Coronavirus Aid Relief and Economic Security Act (CARES ACT), Public Law 116-136 was enacted on March 27, 2020 and made available supplemental Emergency Solutions Grants (ESG) COVID-19 fund to prevent, prepare for and respond to the coronavirus pandemic (COVID-19) among individual and families who are homeless or receiving homeless assistance and to support additional homeless assistance and homeless prevention activities; and

WHEREAS, as a result of the said Act, the U.S. Department of Housing and Urban Development has established, and allocated funds given the immediate needs faced by the communities to mitigate the impacts of the COVID-19 pandemic to qualified jurisdictions upon the approval of a grant application and an amendment to the Consolidated and Annual Action Plan to include the use of ESG-COVID-19 fund to the Plan; and

**WHEREAS,** the County and the five included municipalities of Fountain Inn, Greer, Mauldin, Simpsonville, and Travelers Rest have obtained Urban County status with the United States Department of Housing and Urban Development and are eligible to receive ESG-COVID-19 funds; and

**WHEREAS**, the ESG-COVID fund is available for all eligible applicants in the Greenville County, including residents in City of Greenville, Fountain Inn City limits in Laurens County and Green City limits in Spartanburg County; and

**WHEREAS,** the Greenville County Redevelopment Authority has been the designated agent for applying for and administering HUD funds, and is prepared to develop an Action Plan for ESG-CV2 funding and submit it to HUD on behalf of the County; and

**WHEREAS,** approval of said Action Plan and application by HUD would provide grant of an additional \$1,935,622 in Emergency Solutions Grant with identified approaches that prioritize the unique needs of persons experiencing homelessness in Greenville County and development of partnerships between all levels of government and the private for profit and non-profit sectors to prevent, prepare for and respond to the Coronavirus pandemic (COVID-19) in the County and its incorporated municipalities.

**NOW, THEREFORE, BE IT RESOLVED THAT** Greenville County Council hereby authorizes the Greenville County Redevelopment Authority, as its agent, to apply for and administer ESG-CV funding, if awarded, in accordance with its action plan as submitted to the U.S. Department of Housing and Urban Development.
