Notice is hereby given by the County Council of Greenville County, South Carolina (the "County Council") that the County Council will conduct a public hearing on the proposed adoption of an Ordinance entitled **"AN ORDINANCE TO DEVELOP A JOINT COUNTY INDUSTRIAL AND BUSINESS PARK (TOP EDGE, LLC) IN CONJUNCTION WITH ANDERSON COUNTY, SUCH INDUSTRIAL AND BUSINESS PARK TO BE GEOGRAPHICALLY LOCATED IN ANDERSON COUNTY AND ESTABLISHED PURSUANT TO ARTICLE VIII, SECTION 13 OF THE SOUTH CAROLINA CONSTITUTION, AND SOUTH CAROLINA CODE OF LAWS OF 1976 §4-1-170, ET SEQUITUR, AS AMENDED; TO PROVIDE FOR A WRITTEN AGREEMENT WITH ANDERSON COUNTY PROVIDING FOR THE EXPENSES OF THE PARK, THE PERCENTAGE OF REVENUE APPLICATION, AND THE DISTRIBUTION OF FEES-IN-LIEU OF AD VALOREM TAXES TO THE COUNTIES AND RELEVANT TAXING ENTITIES; TO PROVIDE THAT JOBS TAX CREDITS ALLOWED BY LAW BE PROVIDED FOR BUSINESSES LOCATING IN SAID PARK; TO PERMIT A USER FEE-IN-LIEU OF AD VALOREM TAXATION WITHIN SAID PARK; AND OTHER MATTERS RELATED THERETO."** on Tuesday, September 21, 2021 at 6:00 p.m. either, as determined by the County by Live-Stream on the Greenville County website at <https://www.greenvillecounty.org/livestream.aspx> or in person at the Greenville County Council Chambers located at County Square, 301 University Ridge, Suite 2400, Greenville, South Carolina 29601.
