It is with pleasure that I submit to you for nominations as Code Enforcement Officers, Brian Davis, Eric Latimore, Kelsey Mulherin, Sean Ambrose, Brent Mead, and Bryant Briggs.

Brian Davis is a Building Inspector. Brian holds plumbing and electrical inspector certifications. He has been employed with the county since September 2019.

Eric Latimore is a Building Inspector. Eric holds a plumbing inspector certification. He has been employed with the county since October 2019.

Kelsey Mulherin is a Building Inspector. Kelsey holds a mechanical inspector certification. She has been employed with the county since November 2018 and as a building inspector since October 2020.

Sean Ambrose is a Code Enforcement Officer. Sean is certified through the International Code Council as a Property Maintenance Housing Inspector. He has been employed with the county since June 2019 and with Code Enforcement for 11 months.
