APPROVAL OF MINUTES:

Councilor Meadows moved to approve the minutes of June 7, 2021. The motion carried unanimously.

CONTINUATION OF MILLAGE RATE – BOILING SPRINGS FIRE DISTRICT:

This is a resolution for the continuation of the present millage rate of 29.4 for operations and maintenance for the Boiling Springs Fire District.

John Hansley, Deputy County Administrator was present to answer questions of the committee.

Councilor Kirven moved to approve the resolution for the continuation of the present millage rate of 29.4 for operations and maintenance for the Boiling Springs Fire District. The motion carried unanimously.

RESOLUTION DECLARING THE RESULTS OF SLATER-MARIETTA'S GO BOND REFERENDUM HELD JULY 1, 2021:

This is a resolution declaring the results of Slater-Marietta's G.O. Bond Referendum held July 1, 2021. The resolution submits the question of whether the district shall be authorized to issue not exceeding \$3,000,000 in General Obligation Bonds for the acquisition, construction, installation, furnishing and equipping of a new fire station, renovations to existing fire stations and the acquisition of one or more fire trucks.

Brad Love, Haynsworth Sinkler Boyd was present to answer questions of the committee.

Councilor Kirven moved to approve the resolution declaring the results of Slater-Marietta's G. O. Bond Referendum which authorizes General Obligation bonds in an amount not to exceed \$3,000,000. The motion carried unanimously.
