

RESOLUTION

TO HOLD A PUBLIC HEARING TO CONSIDER ENLARGING THE GREATER GREENVILLE SANITATION DISTRICT TO INCLUDE THE TERRA PINES, TERRA PINES ESTATES, AND TERRA CREEK COURT SUBDIVISIONS.

WHEREAS, pursuant to the provisions of Title 6, Chapter 11, Article 3 of the Code of Laws of South Carolina, 1976, as amended (the “*South Carolina Code*”), the governing bodies of the several counties of the State are authorized to enlarge, diminish or consolidate any existing special purpose districts created prior to March, 1973 that are located within such counties; and

WHEREAS, Greenville County Council is the governing body of Greenville County, South Carolina; and

WHEREAS, the Greater Greenville Sanitation District (the “*District*”) was created by Act No. 1543 of the 1968 Acts and Joint Resolutions of the General Assembly of the State of South Carolina, as amended, and is authorized to collect refuse, garbage and trash within and outside the District; and

WHEREAS, petitions have been submitted to Greenville County Council by a majority of owners the properties located in the Terra Pines, Terra Pines Estates and Terra Creek Court Subdivisions, further described on the attached Exhibits (collectively the “*Properties*”), to have the Properties annexed into and made a part of the District.

NOW, THEREFORE, BE IT RESOLVED that a public hearing be held for the purpose of determining whether the boundaries of the Greater Greenville Sanitation District shall be enlarged to include the Properties.
