Item (3) Road and Bridge Improvements Funding

An ordinance to direct additional funding for road and bridge improvements for the current and next two fiscal years.

- Action: Councilor Tzouvelekas moved to approve an ordinance to direct the County Administrator to provide funding, in addition to the normal amounts allocated to road maintenance amounts, for FY2022, FY2023 and FY2024 in the amount of \$30,000,000 (\$10,000,000 for each year).
- Action: Councilor Meadows moved to amend the ordinance to indicate the \$30 million may be used for roads and/or the Woodruff Road Congestion Relief Project.

Mr. Meadows stated Greenville County was expected to give \$30 million to the State Infrastructure Bank for the Woodruff Road Congestion Relief Project. The SIB had indicated that the County had to use the \$30 million to pay for the bonds. With his amendment, the funds would not have to be used until 2023; the \$30 million that Mr. Tzouvelekas had proposed to be used for roads and bridges could be paid to the SIB for the Woodruff Road Congestion Relief Project. The County would not have to borrow any money or pay any interest. It would also free up the \$15 road maintenance fee on each vehicle, a total of approximately \$7.5 million per year, to be used on a continuous basis.

Mr. Kernell stated if Mr. Meadows' amendment was approved, the County would not have to pay any interest and would reduce future road maintenance funding.

Councilor Fant inquired as to where the County would obtain the \$30 million, if it was not borrowed.

Greenville County Council Committee on Finance December 14, 2021 Page **1** of **2** Mr. Kernell stated it was the same \$30 million that was to be used for road maintenance. Greenville County received recovery money from the Federal Government related to the pandemic. Those funds could be used to capture lost revenue; the amount available was \$31,425,244. The road maintenance fees would remain intact.

Chairman Tripp asked if the ARP (American Rescue Plan) still contained restrictive language in regards to the funds being used for roads.

Mr. Kernell stated the restrictive language was still in place. There had been some proposed legislation that could "soften" those restrictions; however, up to \$10 million could be used for roads.

Chairman Tripp asked if using the \$31,425,244 was on "solid ground."

Mr. Kernell stated those funds could be used to replace lost revenue; staff was comfortable using the money in the manner outlined. Greenville County had received \$50 million thus far; the \$31 million was now "county money" and could be used as Council deemed appropriate.

Motion to amend carried unanimously.

Motion as amended carried unanimously.
