## Item (4) Grants

## a. 2022 LWCF Funding Request – Pavilion Recreation Complex

A funding request in the amount of \$300,000. The Greenville County Parks, Recreation and Tourism Department will match the grant with \$500,000 to complete the project. Local Match to come from H-Tax Revenue Bond Series 2021B

This grant funding will be used for resurfacing the parking lot at the Pavilion Recreation Complex and making accessibility improvements to several park amenities.

# b. 2022 AARP Community Challenge

A funding request by the Greenville County Parks, Recreation, and Tourism Department the amount \$15,000. No County Match required.

These grant funds would be used to make improvements to the outdoor space of the Sterling Community Center. Improvements would include benches, grills, sidewalk games, picnic shelter repairs, landscaping, and ADA access routes.

# c. South Carolina's American Rescue Plan Grant Application

A funding request by the Greenville County Parks, Recreation, and Tourism Department the amount \$651,660. No County Match required.

These grant funds would be used for afterschool programs at the following community centers: Brutontown, Freetown, Phillis Wheatley, Slater, Staunton Bridge, Mt. Pleasant and Sterling.

Councilor Seman moved approval of the 2022 the South Carolina's American Rescue Plan Grant.

## Item (5) Master Lease Authorization for Greenville County Administrative Building
