Item (3) Approval of Minutes

a. March 7, 2022

Councilor Meadows moved to approve the minutes of the March 7, 2022, Regular Committee on Finance meeting.

Motion carried unanimously.

Item (4) Grants

Action:

Presented by: Ruth Parris

a. FY2022 Land and Water Conservation Fund Grant

A resolution to supplement the \$300,000 State Parks, Recreation and Tourism grant application approved by Council on March 1st, which provides Federal Funding for resurfacing the parking lot at the Pavilion Recreation Complex and other improvements to park amenities. The grant total of \$300,000 includes a match from Greenville Parks, Recreation and Tourism in the amount of \$500,000. Local Match to come from H-Tax Revenue Bond Series 2021B.

Action: Vice-Chairman Seman moved to approve the resolution.

Motion carried unanimously.

b. SC Hospital Preparedness Program Grant – Emergency Management

A grant application in the amount of \$217,162.91 to be used to purchase a full spectrum FTIR spectrometer with hot-swappable batteries, APX Next Single Band Model 4.5 Portable 800MhZ radios, Push to Talk Satellite phones with accessories and Multi-band LTE and Motorola Portable Radios with accessories. There is no local match required.

Action:

Councilor Meadows moved to approve the SC Hospital Preparedness Program Grant – Emergency Management.

Motion carried unanimously.

c. SC Jag – Drug Lab Improvement and Enhancement Grant

A grant application in the amount of \$173,266 (Federal Funding: \$155,939 and County Local Match: \$17,327) to be used to purchase a Gas Chromatograph Mass Spectrometer for non-marijuana analysis. Funding Amount/Source: Matching Grants Accounts – FY2022/FY2023 Budget.

Action:

Vice-Chairman Seman moved to approve the SC Jag - Drug Lab Improvement and Enhancement Grant.

Motion carried unanimously.

d. FY2023 Solid Waste Used Oil Grant

A grant application in the amount of \$9,047 to be used to promote used oil, oil filter, and oil bottle recycling. Funds will be used for equipment and supplies for the County's seven oil collection facilities, advertising, and professional development. No local match required.

Vice-Chairman Seman moved to approve the FY2023 Solid Waste Used Oil Grant.

e. FY2023 Solid Waste General Recycling Grant

A grant application in the amount of \$15,000 to be used to promote and educate citizens about food scrap recycling and composting programs. No local match required.

Motion carried unanimously.

f. FY2023 Solid Waste Tire Grant

A grant application in the amount of \$611,800 to be used to fund the Solid Waste Division's contractor costs for current generation tires and provide funds for professional development and public. No local match required.

Vice-Chairman Seman moved to approve the FY2023 Solid Waste Tire Grant.

g. SC Jag – Digital Laser Imaging System Upgrade Grant

A grant application in the amount of \$88,423 (Federal Funding: \$79,580 and County Local Match: \$8,843) to be used to purchase a new laser scanner and upgrade the existing digital laser scanner. This upgrade will double the efficiency of documenting major and violent crime scenes. Funding Amount/Source: Matching Grants Accounts – FY2022/FY2023 Budget.

Action:

Councilor Meadows moved to approve the SC Jag - Digital Laser Imaging System Upgrade Grant.

Motion carried unanimously.

h. SC Rural Infrastructure Authority Grant – Cedar Falls Park

A grant application in the amount of \$231,072 (RIA Portion: \$173,304 and County Local Match: \$57,768) to be used for a stormwater BMP retrofit project that will improve water quality and decrease runoff at Cedar Falls Park in southern Greenville County. Funding Amount/Source: Local Match will come from budgeted Land Development Division CIP approved project.

a. Berea Fire District – Department Anniversary (\$1,000)

A Community Project Application in the amount of \$1,000.00 to assist with celebrating the Berea Fire Department's 60 years of service to the Berea Community as well as Greenville County.

b. Berea Fire District – Mobile Data Terminal (\$4,000)

A Community Project Application in the amount of \$4,000.00 to assist in the purchase of a Mobile Data Terminal to receive vital information from CAD dispatchers.

b. Berea Fire District – Blue Star Marker (\$1,600)

A Community Project Application in the amount of \$1,600.00 to purchase a Blue Star Marker to be placed on Highway 25 to honor the men and women who have served in the U.S. Armed Forces.
