APPROVAL OF MINUTES:

Councilor Tzouvelekas moved to approve the regular minutes of May 23, 2022, June 13, 2022, and June 21, 2022. The motion carried unanimously.

BOILING SPRINGS FIRE DISTRICT MILLAGE CONTINUATION AND ISSUANCE OF GENERAL OBLIGATION DEBT:

The Boiling Springs Fire District requests adoption of a resolution approving the continuation of the present millage rate of 27.5 mills for operations and maintenance and for the approval of a resolution calling for a public hearing and authorizing the District to issue general obligation bonds in an amount not exceeding \$11,250,000.

Larry Finney and John Lucas, representatives of the District were present to answer questions of the committee.

Councilor Meadows abstained due to a conflict of interest.

Councilor Seman moved to approve the continuation of the millage of 27.5 mills and to approve the resolution calling for a public hearing and authorizing the District to issue general obligation bonds in an amount to exceeding \$10,250,000. The motion carried a vote of 4-0 with 1 abstention.

CLEAR SPRING FIRE DISTRICT MILLAGE REQUEST:

Clear Spring Fire District is requesting a millage increase in the District's tax levy of twotenths (2.2) mills from 25.3 to 27.5 which represents CPI and population growth plus "lookback" of one year as allowed per Section 6-1-320 of the South Carolina Code of Laws.

Chief Huffmann was present to answer questions of the committee.

Councilor Meadows abstained due to a conflict of interest.

Councilor Seman moved to approve the ordinance authorizing a 2.2 millage increase from 25.3 to 27.5 for Clear Springs Fire District. The motion carried a vote of 4-0 with 1 abstention.
