GRANT APPLICATION:

RURAL INFRASTRUCTURE AUTHORITY GRANT – STORM WATER QUALITY IMPROVEMENTS:

This is the Rural Infrastructure Authority Grant – Stormwater Quality Improvements in the amount of \$14,000,000. The South Carolina Infrastructure Investment Program is funding \$10,000,000 and the County local match is \$4,000,000. This grant funding will be used to fund a mix of instream improvements and other BMP's designed to improve water quality, reduce nutrients, improve ecological function in the watershed that is part of a larger, multi-organizational effort to improve water quality and facilitates future expansion of the trail system in the Reedy River Watershed.

Ruth Parris, Budget Director and Judy Wortkoetter, Director, Land Development, were present to answer questions of the committee.

Councilor Fant moved to approve the Rural Infrastructure Authority Grant – Stormwater Quality Improvements in the amount of \$14,000,000. The motion carried unanimously.
