# **GRANT APPLICATIONS:**

# UPSTATE REGIONAL WMD BOMB SQUAD HOMELAND SECURITY GRANT:

This is the Upstate Regional WMD Bomb Squad Grant (Office of Homeland Security) in the amount of \$15,000. These grant funds will be used to acquire equipment for the Upstate Regional WMD Bomb Squad. This grant does not require a County match.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Meadows moved to approve the Upstate Regional WMD Bomb Squad Homeland Security Grant in the amount of \$15,000. The motion carried unanimously.

# **UPSTATE REGIONAL WMD SWAT TEAM HOMELAND SECURITY GRANT:**

This is the Upstate Regional WMD SWAT Team Grant (Office of Homeland Security) in the amount of \$20,000. These grant funds will be used to acquire equipment for the Upstate Regional WMD SWAT Team. This grant does not require a County match.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Seman moved to approve the Upstate Regional WMD SWAT Team (Homeland Security) in the amount of \$20,000. The motion carried unanimously.

# VOCA GRANT (FY2022):

This is the FY2022 VOCA Grant in the amount of \$44,202. These funds will be used by the Solicitor's Office to fund the salary portion of one Victim Advocate position. This position assist victims of domestic violence and other crimes being prosecuted. This grant requires a County match of \$8,840 which is already budgeted in the General Fund Matching Grant Account.

Councilor Seman moved to approve the FY2022 VOCA Grant in the amount of \$44,202. The motion carried unanimously.
