Describe your understanding of the position for which you are applying:

I am applying to serve as one of the eleven Trustees on the Greenville County Library Board of Trustees. I understand that, if appointed by the Greenville County Council, I would serve a 4 year term. During that 4 year term I would be required to attend monthly meetings of the full board, as well as meetings of any committees to which I'm assigned.

I understand that the Library Board of Trustees has responsibility for managing the Greenville County Library System and that the details of those responsibilities are enumerated in the Powers and Duties listed on the county's website.

Most importantly, I understand that, as a Trustee, I must serve as a fierce advocate for the library, empowering it to fulfill its responsibility for providing the residents of Greenville County with the best possible library services and the best possible library system, while at the same time maintaining accountability to the public and to the Greenville County Council.

Describe your strengths or skills that would positively contribute to the Library Board of Trustees Commission:

I am a local business owner, the parent of school-age children, and a former librarian.

I will bring all of these perspectives to my service on the Library Board of Trustees.

In my current Chief Operating Officer position, I implement policies, procedures, and standards that help our company do a great job for our guests and for our team members. To succeed as COO, I have to be organized, responsive, and reliable. I also have to be a strong critical thinker, an expert at soliciting and incorporating feedback from my constituents, and I have to be an excellent communicator. These are all skills that I believe are important to being an effective Trustee as well.

While I continue to hone these skills in my current position, I learned and developed them when I was a librarian.

Prior to starting our restaurant company, I spent 15 years working in archives, museums, software/web project management, and libraries. I had my first library job as a sophomore at Cornell University. I later earned my Master in Library and Information Science degree from UCLA and spent the majority of my library career as a federal employee at the National Library of Medicine, which is the world's largest medical library (and a public library).

I started at the National Library of Medicine in a post-graduate leadership development fellowship and, through successive opportunities, eventually became the Deputy Chief of the Public Services Division. In addition to developing all of the leadership skills that I listed above, my time at the National Library of Medicine taught me, in a detailed and comprehensive way, what it takes to run a library -- multi-million dollar budgets, contracts, policies, standards, vision, mission, and public accountability.

As a trained librarian myself, I know what it takes to be a great librarian, and I believe that librarians are great. I understand the breadth and scope of the formal education that librarians receive in order to earn their degrees and I am well-versed in the ethics, standards, and professionalism with which they are taught to and expected to conduct themselves. I also understand the responsibilities that librarians and library systems face in being excellent stewards of public funding and the public trust.

I believe that my first-hand understanding of the workings of a library combined with my more-recent business and entrepreneurship experiences will be excellent additions to the Library Board of Trustees.

In sum, I am a passionate believer in the power of libraries with a grounded understanding of the practicalities of running a large organization with accountability to the public. I will view my Board appointment as an honor and a privilege to be continuously earned.

My community topics of concern that relate to the Library Board of Trustees Commission:

During my 10+ years in Travelers Rest, the library has been a great gathering place for our community. I first started using the library when I was new to the area and needed a quiet place to work. The staff was welcoming and helpful. The facilities have always been clean, well kept, and comfortable.
