I have reviewed both the "Powers and Duties" section about the Library Board that is posted on the County Council website, as well as the Reference Manual for SC Public Library Trustees | 2020 Revised Edition.

This position will act as a public trustee of the library system to keep the library running correctly and ensure that the best possible services, including the following duties:

- Equip, operate, and maintain an effective county-wide library system within the limits of approved appropriations from the County Council
- Acquire books and other library materials and provide for use thereof throughout the County.
- Adopt regulations and policies necessary to ensure effective operation, maintenance, and security of the property of the library system. Ensure those are put in place and followed by the chief librarian.
- Employ, supervise, and manage a chief librarian. Comply with all existing county personnel policies and regulations.
- Responsibilities also include property, budget, and contracts, as well as ensuring the library complies with all relevant laws and operates in a manner that doesn't conflict with existing county guidelines or policies.

- Act as a team member with the other trustees to collaborate, decide, and conduct library business as a team, and when decisions have been made, speak as one voice in support of those decisions.
