| SUBJECT: | Transfer surplus right-of-way Dusty Lane (H0056)                        |

This Division received an application from Open Flame Five Forks, LLC, the owner of the real property identified as TMS# 0548020100712, to acquire surplus right-of-way resulting from the intersection improvement of Dusty Lane and Woodruff Road. SCDOT has realigned Dusty Lane to create a T-intersection at Woodruff Road. The realignment of this intersection resulted in two areas of surplus right-of-way:

- 11,680 square feet (0.27 acres) identified as Parcel A on the "Survey for Open Flame Five Forks, LLC" dated February 7, 2022. This area is the former location of Dusty Lane (H0056) prior to the intersection improvement project. The County accepted Dusty Lane (AKA Elvis Presley Blvd.) into its road inventory by prescription during the mass acceptance on September 8, 1981.
- 0.08 acres identified on the SCDOT exhibit for Project ID 0039660, dated January 19, 2023. This area is surplus right-of-way that the SCDOT transferred to the County by quitclaim deed dated February 2, 2023 and recorded February 7, 2023.

Applicant owns the property adjacent to the surplus right-of-way. SCDOT has completed construction of the new intersection and quitclaimed its surplus right-of-way (0.08 acres referenced above) to the County. This Division has reviewed the applicant's request and determined that the surplus right-of-way will serve no useful public purposes and should be considered for transfer. Staff is requesting Council's approval of an ordinance authorizing the transfer of surplus right-of-way to applicant upon completion of the intersection improvement.
