a. Senior Action Greenville / 55th Anniversary

Chairman Tripp presented a proclamation to Senior Action Greenville. Established in 1968, Senior Action currently offered services to approximately 5,000 people each year, in eight locations throughout the County. Its flagship location, a renovated shopping center, opened in 2021; it was a model program for redefining aging services and has received local, state, and national recognition. In addition to providing expanded services, the center served as an innovative example of social entrepreneurship, with retail tenants helping to support the mission of the organization. Senior Action's services extend far beyond the walls of its centers, with programs like medical transportation, lawn care assistance, home delivered meals (in partnership with Meals on Wheels), and affordable housing at its 48-unit independent living apartment complex.

Approximately 35% (or 189,000) of the County's residents were over the age of 55, with the number of elderly citizens growing by 50% since 2010. Greenville County's percentage of seniors was the highest in the State. The challenges to care for this population were growing exponentially as was the cost to provide services.

Greenville County Council recognized the continued efforts of Senior Action and thanked them for their contribution to Greenville County over the past 55 years.

d. Project Blue / Fee in Lieu of Tax Agreement

Action:

Chairman Pro Tem Kirven moved for approval at second reading an ordinance authorizing the execution and delivery of a fee in lieu of tax agreement by and between Greenville County, South Carolina and a company of companies known to the County at this time as Project Blue, with respect to certain economic development property in the County, whereby such property would be subject to certain payments in lieu of taxes; and other matters related thereto.

Motion carried unanimously.

e. County of Greenville / FY 2024 Budget

Action:

Chairman Pro Tem Kirven moved for approval at second reading an ordinance adopting the County of Greenville FY 2024 Budget.

Action:

Councilor Shaw moved to amend the FY 2024 Budget to provide that any expenditure related to the creation, development, enabling and/or implementation of Affordable Housing shall require that veterans of the United States armed services, or the State of South Carolina National Guard, be given priority over non-veterans for recruitment, retention, application, subsidy, and economic support. Such priority shall be affirmatively set forth in any implementation instruments by any Greenville County official and by any developer of lands, buildings, or properties. Further, the same shall be reported annually to County Council.

Councilor Harrison inquired about the legality of Councilor Shaw's proposed amendment.

Councilor Shaw stated Council had been informed numerous times by the County Attorney and the Attorney General's Office that any action Council took was presumed legal unless and until challenged by a court.

Mr. Tollison stated he was unable to provide a legal opinion regarding Mr. Shaw's amendment without researching the issue.

Vice-Chairwoman Seman stated the County was not responsible for vetting applications for affordable housing; various local agencies were responsible for doing so. Ms. Seman stated she was certain those agencies took into account the important of providing services to veterans, and others, in need of affordable housing.

Chairman Tripp inquired as to where County monies were appropriated for affordable housing.

Mr. Kernell stated GCRA was the County's housing partner. He suggested obtaining a true legal opinion regarding the proposed amendment, given the Fair Housing laws that were in place.

Action: Chairman Tripp ruled Councilor Shaw's amendment, as proposed, out of order.

Chairman Tripp suggested Mr. Shaw research the issue and report back to Council. As currently drafted, the proposed amendment was not appropriate. He stated the proposed amendment must be directed to the correct agency, not Greenville County.

Councilor Shaw moved to amend the FY 2024 Budget to reflect a reduction of \$1.5 million for the Greenville Transit Authority.

Motion to amend was denied.

Councilor Shaw moved to amend the FY 2024 Budget to reflect a reduction of \$3.5 million for the Natural Resources Special Revenue Fund.

Councilor Harrison stated the proposed \$4.5 million to the Natural Resources Special Revenue Fund included monies for the Conestee Dam Project.

Councilor Shaw stated the Conestee Dam Project was important. However, it was a long-term expense; he suggested the County bond the monies needed. Mr. Shaw stated he planned to propose an amendment for the project.

Motion to amend was denied by a roll call vote of three (Russo, Shaw and Tzouvelekas) in favor and nine (Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Councilor Shaw moved to amend the FY 2024 Budget to reflect a reduction of \$25,000 from the Human Relations budget.

Councilor Harrison stated he respected Mr. Shaw's attempts to reduce the budget; however, "nickel and diming" departments for \$25,000 appeared to be simply "playing politics." The projected deficit was \$21 million.

Councilor Shaw stated he was the only Council Member making any suggestions.

Greenville County Council Regular Council Meeting Councilor Fant stated the Human Relations Commission provided a vital service to the community; it recently celebrated 55 years of providing fair housing. He acknowledged the members of the Human Relations Commission and departmental staff who were in attendance and thanked them for their hard work.

Councilor Shaw stated the Human Relations Commission used Greenville County tax money to purchase \$3000 worth of umbrellas to promote its personal views.

Councilor Harrison stated each Council Member received \$20,000 in Community Project monies each year as well as a salary of approximately \$30,000. He suggested cutting those amounts.

Councilor Blount stated it appeared to him that Mr. Shaw was looking at each line item. It was hard for him to make a decision about some of them as Council had not discussed them in depth. He suggested Council should have been working on the budget prior to the evening's meeting.

Motion to amend was denied by a roll call vote of three (Russo, Shaw and Tzouvelekas) in favor and nine (Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Action:

Councilor Shaw moved to amend the FY 2024 budget by freezing the number of all County positions in the current budget so that there were no additional positions. The amendment would not limit or prevent any department or agency from filling open vacancies from the positions that existed prior to this amendment.

Chairman Tripp asked Mr. Shaw if the amendment would eliminate the positions recommended in the proposed budget.

Councilor Shaw stated the proposed amendment would eliminate those positions. He stated that he had not heard from Sheriff Lewis regarding the need for additional staff.

Chairman Pro Tem Kirven stated Sheriff Lewis had outlined the need for additional deputies during the Council Retreat, held earlier in the year.

Councilor Tzouvelekas stated he had attended the Council Retreat and it was his understanding Sheriff Lewis indicated his office had "adequate resources." Mr. Tzouvelekas stated that may have changed since the retreat.

Motion to amend was denied by a roll call vote of two (Shaw and Tzouvelekas) in favor and ten (Russo, Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Action:

Councilor Shaw moved to amend the FY 2024 Budget to provide that all Solid Waste operations must be revenue neutral.

Chairman Tripp inquired about the impact of the proposed amendment in terms of increased landfill fees Greenville County residents would be responsible for paying.

Councilor Shaw stated he did not know what the impact would be.

Action:

Councilor Shaw called for the question.

Without objection, the motion to call for the question carried.

Motion to amend was denied by a roll call vote of two (Shaw and Tzouvelekas) in favor and ten (Russo, Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Action:

Councilor Shaw moved to amend the FY 2024 Budget to provide that all Animal Shelter operations must be revenue neutral.

Councilor Shaw stated he loved animals; however, the County could not continue to spend so much money on the shelter. It was considered a luxury and the people using the shelter should pay for it.

Chairman Tripp inquired about the impact of the proposed amendment in terms of increased fees Greenville County residents would be responsible for paying.

Councilor Shaw stated he did not know what the impact would be.

Action:

Councilor Shaw called for the question.

Without objection, the question was called.

Motion to amend was denied by a roll call vote of two (Shaw and Tzouvelekas) in favor and ten (Russo, Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Action:

Councilor Tzouvelekas moved to amend the FY 2024 Budget to reflect a decrease of \$2 million for Affordable Housing, resulting in a .7 reduction in the millage rate.

Motion to amend was denied by a roll call vote of two (Shaw and Tzouvelekas) in favor and ten (Russo, Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Action:

Councilor Tzouvelekas moved to amend the FY 2024 Budget to reflect a transfer of \$700,000 from the Municipal Paving Sharing Fund to the Greenville County General Fund, resulting in a .02 reduction in the millage rate.

Motion to amend was denied by a roll call vote of two (Shaw and Tzouvelekas) in favor and ten (Russo, Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Action:

Councilor Tzouvelekas moved to amend the FY 2024 Budget to reflect a transfer of \$300,000 from Next Funding to the Greenville County General Fund, resulting in a .01 reduction in the millage rate.

Mr. Kernell stated the \$300,000 for Next Funding was for both years of the budget; \$150,000 for each year.

Councilor Tzouvelekas amended the amendment to reflect \$150,000 as opposed to \$300,000.

Motion to amend was denied by a roll call vote of two (Shaw and Tzouvelekas) in favor and ten (Russo, Barnes, Blount, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in opposition.

Action:

Councilor Tzouvelekas moved to amend the FY 2024 Budget to reflect deletion of Community Project monies in the amount of approximately \$24,000 available to each Council Member for donation to local organizations.

Mr. Kernell stated each Council Member received \$20,456 per year for Community Projects, for a total of \$245,472.

Motion to amend was denied by a roll call vote of four (Shaw, Harrison, Tzouvelekas and Bradley) in favor and eight (Russo, Barnes, Blount, Mitchell, Seman, Fant, Kirven and Tripp) in opposition.

Councilor Bradley made the following motion on behalf of Council Members Chairman Tripp, Vice-Chairwoman Seman, Chairman Pro Tem Kirven, Councilor Fant, Councilor Harrison, Councilor Mitchell, Councilor Barnes and himself.

Action:

Councilor Bradley moved to amend the FY 2024 Budget from a proposed 11 mill increase to a 7 mill increase as follows:

- 1. Reduce the proposed General Fund millage rate by 3.0 mills
- 2. Increase Building / Code Enforcement Revenues by \$2,947,465
- 3. Increase transfer from Workers Compensation Fund by \$500,000
- 4. Increase transfer from Infrastructure Bank by \$1,000,000
- 5. Reduce Health Insurance premiums by \$3,000,000
- 6. Reduce transfer from the General Fund to Capital Projects for the following projects:
 - a. Information Technology \$400,000
 - b. Register of Deeds Historical Documents \$500,000
 - c. Sheriff's Office Target System \$800,000
- 7. Reduce the Solid Waste millage rate by 0.5 mill
- 8. Increase Solid Waste Revenue by \$1,500,000
- 9. Reduce the Natural Resources Fund by \$2,000,000 for the Conestee Dam
- 10. Reduce Parks, Recreation and Tourism millage rate by 0.5 mill
- 11. Increase transfer from Hospitality Tax Fund by \$1,500,000

- 3. Increase transfer from Workers Compensation Fund by \$500,000
- 4. Increase transfer from Infrastructure Bank by \$1,000,000
- 5. Reduce Health Insurance premiums by \$3,000,000

 - a. Information Technology \$400,000
 - b. Register of Deeds Historical Documents \$500,000
 - c. Travelers Rest Maintenance Camo Roof Replacement \$280,000
 - d. Video Laryngoscopy \$200,000
- 7. Reduce the Solid Waste millage rate by 0.5 mill
- 8. Increase Solid Waste Revenue by \$1,500,000
- 9. Add \$500,000 to the Natural Resources Fund for the Conestee Dam
- 10. Reduce Medical Charities fund by \$500,000

- 11. Reduce Parks, Recreation and Tourism millage rate by 0.5 mill
- 12. Increase transfer from Hospitality Tax Fund by \$1,500,000

Motion to amend carried by a roll call vote of eight (Barnes, Harrison, Mitchell, Seman, Fant, Bradley, Kirven and Tripp) in favor and four (Russo, Blount, Shaw and Tzouvelekas) in opposition.

Item (12) Ordinances – First Reading

a. Greenville County Historic and Natural Resources Trust (HNRT) / HNRT Project Campfire

Chairman Pro Tem Kirven presented for first reading an ordinance authorizing the Greenville County Historic and Natural Resources Trust (HNRT) to provide funding for a project known to the County at this time as HNRT Project Campfire.

Chairman Tripp stated the item would remain on the floor.

Item (13) <u>Committee Reports</u>

a. Committee of the Whole

i. Revised Greenville County Board and Commission Policy

Action:

On behalf of the Committee, Vice-Chairwoman Seman moved to approve the revised Greenville County Board and Commission Policy as recommended by the Committee of the Whole.

Motion carried unanimously.

Item (14) Administrator's Report

Mr. Kernell thanked Council for supporting the proposed budget. He also recognized all the County employees who were in attendance for their support as well.

Item (15) Requests and Motions

- Councilor Shaw stated he was glad to hear Councilor Mitchell's voice during the meeting. He hoped he would be back in person soon.
- Councilor Harrison stated the University Redevelopment Project would bring an estimated \$1 billion in private investment to Greenville County. Once completed, the property was expected to bring in approximately \$25 million in property tax revenue annually. Mr. Harrison stated he, along with several of his colleagues, planned to present a resolution at the next Council meeting scheduled for June 20. The resolution would commit all net new revenues from the project to County property tax reductions. If passed, the resolution would set the stage to bring down the County's tax millage to a lower rate, resulting in tax savings for property owners and dropping the need for millage increases for the coming years.

- Chairman Pro Tem Kirven reminded everyone of the 79th anniversary of the D-Day invasion which occurred during World War II on June 6, 1944. He thanked Sheriff Lewis and his staff for all their hard work protecting the citizens of Greenville County.
- Councilor Blount stated the budget consisted of many issues in addition to public transportation, affordable housing and all County staff, all for which he was an advocate.
- Chairman Tripp stated under the proposed budget, as amended earlier in the evening, a home with tax value of \$100,000 would see an increase of approximately \$28 per year. That amount did not represent an increase of 23%. Mr. Tripp stated the millage increase was a responsible act, needed to ensure law enforcement and EMS positions were not cut. Greenville County had not raised taxes in 28 years; however, Council had to deal with the facts and realities of increased costs. Currently, it cost the County \$42,000 to hire a deputy; a few years ago, that amount was \$28,000. Mr. Tripp stated Greenville County continued to grow. It was Council's responsibility to make informed decisions, based on facts and not the voices of fear and negativity.
- Councilor Tzouvelekas stated the County had raised its budget by \$100 million from 2020; the population of Greenville County had only risen by 30,000. Mr. Tzouvelekas stated he understood the County was growing, but, he wanted everyone to "put those number together."
- Councilor Fant stated the evening's meeting and the last few weeks had been a democratic republic process at work. It had been brutally painful. He applauded Chairman Tripp for his leadership; he had been "clobbered" the past few weeks.

Item (16) Adjournment

Action: Chairman Pro Tem Kirven moved to adjourn the meeting.

Motion carried and the meeting adjourned at 8:34 p.m.
