It is with pleasure that I submit to you for nominations as Code Enforcement Officers, Darren Medlin, Junior Nunez, Jim Cerniauskos, Chris Barnes, and Stephen Hodges.

Darren Medlin is a Building Inspector. Darren holds 2 residential inspector certifications with ICC. He has been employed with the county as a building inspector for over 1 year.

Junior Nunez is a Building Inspector. Junior holds 1 inspector certification with ICC. He has been employed with the county as a building inspector for over 9 months.

Jim Cerniauskos is a Building Inspector. Jim holds 1 inspector certification with ICC. He has been employed as a building inspector with the county for over 6 months.
