CALL TO ORDER:

Chairman Kirven called the Finance Committee meeting to order at 5:00 p.m.

INVOCATION:

Chairman Kirven provided the invocation.

APPROVAL OF MINUTES:

Councilor Seman moved to approve the regular minutes of November 28, 2022. The motion carried unanimously.

GRANT APPLICATIONS:

EMS GRANT IN AID:

This is the SC DHEC – EMS Grant in Aid FY2023 in the amount of \$36,175.00. This grant would allow the Emergency Medical Services Division to be able to acquire a Central Square server dedicated to support implementation of operational projects within the CAD system. This grant requires a County match of \$3,290.79 which will come from the Matching Grants Account - FY2023.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Tripp moved to approve the EMS GIA FY2023 in the amount of \$36,175.00. The motion carried unanimously.

FIREHOUSE SUB GRANT:

This is the Firehouse Sub Grant in the amount of \$42,612.21. These grant funds will allow the EMS Department to acquire personal protection equipment for rescue and mass casualty medical supplies. This grant does not require a County match.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Seman moved to approve the Firehouse Sub Grant in the amount of \$42,612.21. The motion carried unanimously.

HAZARDS MATERIALS EMERGENCY PREPAREDNESS GRANT (HMEP):

This is the Hazards Materials Emergency Preparedness Grant (HMEP) in the amount of \$25,000. These grant funds will be used for a multi-jurisdictional Hazmat Transportation incident full scale exercise. This grant does not require a County match.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Tripp moved to approve the Hazards Emergency Preparedness Grant in the amount of \$25,000. The motion carried unanimously.

EXPANDED INFRASTRUCTURE SUPPORT GRANT - NATIONAL NETWORK OF PUBLIC HEALTH INSTITUTES:

This is the Expanded Infrastructure Support Grant – National Network of Public Health Institutes in the amount of \$20,000. This grant will allow the Coroner's Office to acquire digital cameras for deputy coroners. This grant does not require a County match.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Seman moved to approve the Expanded Infrastructure Support Grant in the amount of \$20,000. The motion carried unanimously.

SC OPIOID RECOVERY FUND BOARD REQUEST:

This is the SC Opioid Recovery Fund Board Request Grant in the amount of \$2,094,326. The funds will support equipment, computers, and a portable Mass Spectrometer, as well as several positions and training funds in the Sheriff's Office. This grant does not require a County match.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Tripp moved to approve the SC Opioid Recovery Funds Board Request Grant in the amount of \$2,094,326. The motion carried unanimously.

Councilor Seman moved to approve the ordinances consenting to the issuance of General Obligation bonds to provide funding for (1) the construction and equipping of the Simpsonville Magistrate Office in an amount not to exceed \$6,000,000; and (2) acquisition of a new fire truck and related equipment for the River Falls Fire District in an amount not to exceed \$800,000.
