### CALL TO ORDER:

Chairman Kirven called the Finance Committee meeting to order at 5:00 p.m.

### INVOCATION:

Councilor Seman provided the invocation.

### **APPROVAL OF MINUTES:**

Councilor Tripp moved to approve the minutes of the regular meeting of October 9, 2023. The motion carried unanimously.

### **GRANT APPLICATIONS:**

### VOCA GRANT:

This is the VOCA grant in the amount of \$44,203. The grant funding will be used by the Solicitor's Office to fund the salary portion of one Victim Advocate position. This position will assist victims of domestic violence and other crimes being prosecuted. This grant requires a County match of \$8,841 which is budgeted in the Matching Grant Account.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Tripp moved to approve the VOCA grant in the amount of \$44,203. The motion carried unanimously.

# STATE AND LOCAL CYBERSECURITY GRANT:

This is the Stata and Local Cybersecurity Grant in the amount of \$1,800,000. The State and Local Cybersecurity Grant Program provides funding to eligible entities to address cybersecurity risks and threats to information systems owned or operated by, or on behalf of, state, local, or tribal governments. If awarded, the County will use the funds to protect critical infrastructure including all Greenville County networks. The County will use the funding for software subscriptions to install advanced ransomware protection on all County devices. This grant does not require a County match.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Seman moved to approve the State and Local Cybersecurity Grant in the amount of \$1,800,000. The motion carried unanimously.

## EMS GRANT-IN-AID FY2024:

This is the EMS Grant-In-Aid FY2024 grant in the amount of \$35,130.54. This grant would allow the Emergency Medical Services Division to be able to acquire the Stryker Power-LOAD System (an automatic power-loading stretcher fastener system) and special operations uniforms. This grant requires a County match of \$1,932.18 which is budgeted in the Matching Grant Account.

Ruth Parris. Budget Director was present to answer questions of the committee.

Councilor Seman moved to approve the EMS Grant-In-Aid FY2024 grant in the amount of \$35,130.54. The motion carried unanimously.

### SC HOSPITAL PREPAREDNESS GRANT FOR EMERGENCY MANAGEMENT:

This is the SC Hospital Preparedness Grant – Emergency Management in the amount of \$31,500. This grant would allow the Emergency Management Division to acquire a MegaGo case which will provide wireless internet and phone capability to support multiple locations in the event of a disaster and a deployable device to support wireless telephone communications via VOIP for coalition partners.

Ruth Parris, Budget Director was present to answer questions of the committee.

Councilor Tripp moved to approve the SC Hospital Preparedness Grant – Emergency Management in the amount of \$31,500. The motion carried unanimously.

# 170 PATRIOT HILL, LLC - NAME CORRECTION:

This is an ordinance authorizing the correction of the name of 170 Patriot Hill LLC on a fee in lieu of tax agreement by and between Greenville County and 170 Patriot Hill Drive LLC.
