Re:	Application for Recommendation for Historic Property Designation:
	Cedar Falls Park

The Greenville County Historic Preservation Commission has been asked by the property owner, Greenville County on behalf of District 26 Councilman Rick Bradley, to request County historic designation for Cedar Falls Park, located at 201 Cedar Falls Road in unincorporated Fountain Inn. The Commission voted to approve the application for recommendation at its May 18, 2023 meeting.

Cedar Falls Park is a place of historical significance to the Fountain Inn area of Greenville County. Early industrialists built a dam along the river in 1820 to provide electricity to a sawmill, textile mill, and cotton gin. In 1910, a larger dam was built to power nearby Fork Shoals Mill. The dam operated for four decades until it was torn down in 1950. The County has preserved the ruins of the old mill on the park site.

Therefore, staff is requesting that the Planning and Development Committee forward this request to County Council for consideration to be added to the County's Historic Property Inventory.

The Cedar Falls Park consists of two separate dams and ruins associated with various industrial buildings and structures formerly located on the Reedy River. The construction on the property occurred over various stages from the 1820s through 1910. Hudson Berry built a small dam that spanned a northwest fork of the river in the 1820s to power a textile mill, grist mill, sawmill, and cotton gin. The dam is constructed of stone and concrete and is approximately 15 feet in height and 30 feet in length. An eight-inch-high concrete curb was also built across the river at the top of the shoals to channel water towards the dam in dry season. There are stone foundation ruins of some of the 1820s building about 40 yards west of the dam. Around 1910, a large dam was built across the entire river in order to supply electricity to the Fork Shoals Mill and surrounding community. The large dam is around 20 feet tall and constructed of stone and concrete. There are stone wall abutments on either side of the dam about 35 feet tall with spillway ports on the western side.¹

Remains of the foundation piers for the penstock pipe remain along the river spanning about 50 yards downriver from both dams. The large concrete generator pier used in producing electricity still stands (approximately ten feet in height) near the last penstock pier. Once the Fork Shoals Mill began buying its electrical power from Duke Power, the power plant buildings were demolished in 1950.²

Cedar Falls Park opened in 2010 and is currently owned by Greenville County and is a public park. The County has preserved the ruins of the old mill on the site. In addition to the preservation of the historic ruins, the park includes walking and biking trails, a playground, a picnic shelter, a volleyball court, and public restrooms.³
