1. Call to Order

2. Invocation

3. Approval of the minutes of the August 15, 2023 - Committee meeting

4. Greater Greenville Sanitation Annexation Request - 103 Pebble Creek Dr and 49 Cambridge Dr

5. Greater Greenville Sanitation Annexation Request - Idlewild, Micheland Place and Carolina Hills Subdivisions and portion of Blue Sky Park Subdivision

6. Paris Mountain Wildfire Mitigation Plan - Annex to the Greenville County Multi-Jurisdictional Hazard Mitigation Plan

Jessica Stumpf, Director of Greenville County Emergency Management, explained Greenville County is threatened by a number of natural hazards that endanger the health and safety of the population, jeopardize its economic vitality, and imperil the quality of its environment. To help mitigate these hazards, Greenville County adopted the 2020 Multi-Jurisdictional Hazard Mitigation Plan (HMP). The HMP outlines mitigation planning activities designed to reduce the impact of natural hazards on the community.

Within the HMP, one of the tasks was to prepare a Wildfire Plan for the Paris Mountain area. Greenville County was able to obtain Federal Grant funds to assist with the preparation of this plan. In accordance with the Grant, the Paris Mountain Wildfire Mitigation Plan must now be adopted by County Council and incorporated into the existing 2020 HMP.

Discussion: Mr. Shaw asked how the adoption of the plan and associated action items will be funded by Greenville County? Ms. Stumpf stated it will depend on funding available and may be subject to additional grant funding. Mr. Shaw asked how the budget requirements would be defined and who would define them? Ms. Stumpf stated the budget requirements will be defined by Emergency Management, Floodplain Management

and Code Compliance, working within those budgets. Mr. Shaw asked if supplemental funds will be required for fiscal years 2024 and 2025? Ms. Stumpf stated not that she was aware of.

Motion: by Mr. Fant to approve and forward to full Council. The motion carried unanimously by voice vote.

7. Adjourn

Mr. Fant made a motion to adjourn. The motion carried unanimously by voice vote and the meeting was adjourned at 5:07 p.m.
