**NOTICE OF PUBLIC HEARING**

Notice is hereby given by the County Council of Greenville County, South Carolina (the "County Council") that the County Council will conduct a public hearing on the proposed adoption of an Ordinance entitled "AN ORDINANCE AUTHORIZING THE EXECUTION AND DELIVERY OF A SPECIAL SOURCE CREDIT AGREEMENT BY AND BETWEEN GREENVILLE COUNTY, SOUTH CAROLINA, AND KPMT NO LIMIT, LLC, WITH RESPECT TO CERTAIN INVESTMENT IN QUALIFYING INFRASTRUCTURE RELATED TO THE CONSTRUCTION OF A PREDOMINANTLY RESIDENTIAL MIXED-USE PROJECT IN THE COUNTY TO INCLUDE CERTAIN AFFORDABLE AND WORKFORCE HOUSING IN THE COUNTY (THE "PROJECT"), WHEREBY SUCH PROJECT WILL BE SUBJECT TO PAYMENTS IN-LIEU-OF TAXES BY VIRTUE OF ITS LOCATION IN A JOINT COUNTY INDUSTRIAL AND BUSINESS PARK, AND TO APPLICATION OF CERTAIN SPECIAL SOURCE CREDITS; AND OTHER MATTERS RELATED THERETO."

The public hearing will be held in the Greenville County Council Chambers located at 301 University Ridge, Greenville, South Carolina 29601, at 6:00 p.m. (or at such time as other public hearings are concluded), on Tuesday, January 16, 2024, in conjunction with a regularly scheduled meeting of the County Council.

Subject to the normal rules of County Council regarding appearances, individuals wishing to speak in favor or in opposition to this ordinance must register on-site between 5:30 and 6:00 the evening of the meeting. All citizens who appear will be given an opportunity to express their views for or against the adoption of the ordinance.
